# **Notes and Sources**



The notes and sources below provide technical information about the indicators used in the California County Data Book. The indicators are organized alphabetically and include information about data in the County Profiles, the County Ranking charts and the Data by Race/Ethnicity charts. The California County Data Book relies heavily on survey data from the U.S. Census Bureau and California Health Interview Survey. As with all survey data, information from these sources are estimates based on samples of the population and should be interpreted as best-available representations of the community rather than as precise estimates.

#### Children, ages 0-17, in low income families

Includes children, ages 0-17, who live in families with income less than 200% of the official poverty level (adjusted for household size) in the prior year. Children Now analysis of data from the U.S. Census Bureau's 2005 American Community Survey 1% Public Use Microdata Sample (PUMS), as accessed through IPUMS, a project of the Minnesota Population Center, <a href="http://www.ipums.org">http://www.ipums.org</a> (January 26, 2007).

#### Children diagnosed with asthma

Includes children, ages 1-18, ever diagnosed with asthma. 2005 California Health Interview Survey, "Ever diagnosed with asthma compared by County or county group," <a href="http://www.chis.ucla.edu">http://www.chis.ucla.edu</a> (March 28, 2007). Counties with fewer than 10 cases or those with statistically unstable values are not reported.

### Children in good or excellent health

Includes children, ages 0-18, in "excellent," "very good," or "good" health. 2005 California Health Interview Survey, "Health status compared by County or county group," <a href="http://www.chis.ucla.edu">http://www.chis.ucla.edu</a> (March 28, 2007). Counties with fewer than 10 cases or those with statistically unstable values are not reported.

#### Children living in poverty

Includes children, ages 0-17, who live in families with income less than the official poverty level (adjusted for household size) in the prior year. U.S. Census Bureau, 2005 American Community Survey, "Poverty Status in the Past 12 Months by Sex by Age," 2005, and Census 2000 Summary File 3," Poverty Status in 1999 by Age," 2000. Census year 2000 estimates are provided for Alpine, Amador, Calaveras, Colusa, Del Norte, Glenn, Inyo, Lassen, Mariposa, Modoc, Mono, Plumas, San Benito, Sierra, Siskiyou, Tehama, Trinity and Tuolumne counties.

#### Children who are in school

Includes children, ages 3-17, who are in school. U.S. Census Bureau, 2005 American Community Survey, "School Enrollment by Level of School by Age For The Population 3 Years And Over," 2005, and Census 2000 Summary File 3, "Sex By School Enrollment By Age For The Population 3 Years And Over," 2000. Counties with fewer than 10 cases are not reported. Census year 2000 estimates are provided for Alpine, Amador, Calaveras, Colusa, Del Norte, Glenn, Inyo, Lassen, Mariposa, Modoc, Mono, Plumas, San Benito, Sierra, Siskiyou, Tehama, Trinity and Tuolumne counties.

#### Children who are U.S. citizens

Includes citizenship status of children, ages 0-17. "Citizen" is defined as a person born in the United States or who has gained naturalized citizenship status. 2005 American Community Survey, "Sex by Age By Citizenship Status," 2005, and Census 2000 Summary File 4, "Sex By Age By Citizenship Status," 2000. #### Children who ate fast food in the prior day

Counties with fewer than 10 cases or those with statistically unstable values are not reported.

#### Children who never exercise

Asked of adolescents and children who attended school last week or the last school year and includes those who responded that they did not walk, bike, or skate to school during the prior week. 2005 California Health Interview Survey, "Walked/Biked/Skated to or from school in past week compared by County or County Group," <a href="http://www.chis.ucla.edu">http://www.chis.ucla.edu</a> (March 16, 2007). Counties with fewer than 10 cases or those with statistically unstable values are not reported.

#### Children who speak another language at home

Includes home language for children, ages 5-17. U.S. Census Bureau, 2005 American Community Survey, "Age by Language Spoken at Home for the Population 5 Years and Over," 2005, and Census 2000 Summary File 3, "Age by Language Spoken at Home by Ability to Speak English for the Population 5 Years and Over," 2000. Counties with fewer than 10 cases are not reported. #### Children with dental insurance

# Children with regular access to a doctor

Usual source of medical care reported for children, ages 0-18. #### **Detailed Race/Ethnicity**

"Other Asian" includes all children of Asian heritage not included in other featured Asian categories. "Pacific Islander" includes all children of Pacific Islander or Native Hawaiian heritage.

# **English Learners**

Percent of all public school students who are designated as English Learners by their local school district. # Family income

Family income is reported as a percentage of the Federal Poverty Level (FPL), which is adjusted annually for cost of living and is scaled to household size. In 2006, the FPL for a family of four was \$20,000.

# Households receiving food stamps

#### Insured or not insured

Health insurance coverage status for children, ages 0-18. 2005 California Health Interview Survey, "Currently insured compared by County or county group," <a href="http://www.chis.ucla.edu">http://www.chis.ucla.edu</a> (April 11, 2007). Counties with fewer than 10 cases or those with statistically unstable values are not reported. Percents may not sum to 100% due to rounding.

#### **Language Fluency**

"Fluent in English" includes native speakers, fluent English proficient and initially English proficient students. "English Learners" have not yet mastered English, and "Redesignated English Proficient" students have mastered English within the last school year. Local school districts determine individual students' English language proficiency based on testing results and teacher recommendations.

#### Low birthweight infants

Includes infants whose birth weight was less than 2,500 grams. Location is based on mother's place of residence as reported on child's birth certificate, and ethnicity is based on mother's race/ethnicity. Children Now analysis of California Department of Health Services 2005 Public Use Birth File (Sacramento, CA: California Department of Health Services, Center for Health Statistics, 2005). Counties with fewer than 10 cases are not reported.

### Meet UC/CSU entrance requirements

Includes students who have completed the coursework necessary to apply to the University of California or California State University systems. ### Mothers receiving early prenatal care

Mothers whose first prenatal care visit took place within the first three months of pregnancy. Location is based on mother's place of residence as reported on child's birth certificate, and ethnicity is based on mother's race/ethnicity. Children Now analysis of California Department of Health Services 2005 Public Use Birth File (Sacramento, CA: California Department of Health Services, Center for Health Statistics, 2005). Counties with fewer than 10 cases are not reported.

#### Multi-County estimate for health data

The California Health Interview Survey groups responses into multi-county groups for select low-population counties. County groups are as follows: Alpine, Amador, Calaveras, Inyo, Mariposa, Mono and Tuolumne counties; Del Norte, Lassen, Modoc, Plumas, Sierra, Siskiyou and Trinity counties; Colusa, Glenn and Tehama counties.

#### People in overcrowded households

Overcrowded households are those with more than 1.0 occupant per room. Data is not available for low-population counties. U.S. Census Bureau, 2005 American Community Survey, "Tenure by Occupants per Room," 2005. Counties with fewer than 10 cases are not reported.

### Per capita family income

Median per capita income is reported in order to adjust for household size. Children Now analysis of aggregate income and number of people in households data tables from the Census Bureau. Per capita income is calculated by dividing aggregate household income by the number of people in households. For low-population counties for which Census year 2000 data is reported, median per capita income is adjusted by a factor of 1.17, consistent with the Consumer Price Index inflation factor for the period between 1999 and 2005.
