San Diego County School Districts Liaisons

The following list includes names and phone numbers of Homeless Liaisons for each San Diego County School District. These liaisons have been identified by each school district as mandated by the U.S. Department of Housing and Urban Development through the McKinney-Vento Act.

One of the mandates from the Federal McKinney-Vento Act is that public mainstream schools are to remove barriers to education for homeless youth, which included the identification of a homeless liaison. The Act did “Grandfather” in a few independent non-program related schools, which were already established to teach homeless youth. However, the “Grandfather” clause did not relieve any district from its responsibility to assist homeless youth. San Diego is fortunate to have one of the independent schools that teach homeless youth. That school is the Monarch School, for more information they can be reached at 619.685.8242.

In addition to the Monarch School, there are other program related schools for homeless youth. For example, the St. Vincent de Paul Village – Toussaint Teen Center, which, as one of its program components, offers a school for its residents. The program related schools were not affected by the McKinney-Vento Act.
