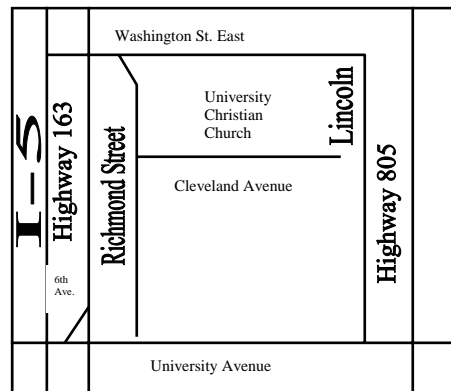

Strategic Plan: Goals and Achievements

The NAMI San Diego Board of Directors adopted a three-year strategic plan in the fall of 2003. Following are the Plan's Visions and the 2004 Key Indicators. To see how we are doing, compare the information through June, 2004 on pages 2 and 3 with the full-year indicators below. *Hint: look for the grassroots.*



San Diego residents will recognize NAMI San Diego as their voice on mental illness.

- Albright I&R Center will handle 4500 contacts
- 8 Family-to-Family classes are filled and held
- First Contact packets are distributed to 500 providers
- Attendance at Walk/Fair is 500

NAMI San Diego provides culturally sensitive services to all those dealing with mental illnesses.

- Family-to-Family classes: 3 Spanish language and one class in South San Diego
- Family support groups: 2 Spanish language and one group in South San Diego
- Fact sheets: Complete set available in Spanish
- Task Forces: Meeting on regular basis, include Latino and African American leaders
- Website: includes dedicated area for resources in Spanish

Families and consumers are empowered to strive for recovery.

- 90% of Family-to-Family teachers complete NAMI training before teaching a class
- 100% of Peer-to-Peer mentors complete mentor training before facilitating a class
- 75% of NAMI C.A.R.E. facilitators complete NAMI training before facilitating a group
- 50% of support groups sponsored by NAMI San Diego use the NAMI Support Group model

Community members in the Greater San Diego area can rely on NAMI San Diego to help improve the quality of life of everyone affected by mental illnesses.

- Capital Campaign and Business plans adopted
- Owned space is designed for maximum participation of necessary staff members, key volunteers, other volunteers, and class and support group participants
- Staff and key volunteer positions are developed and filled to meet organization's needs for administration, fiscal management, program development and support, financial development, community outreach, and membership and volunteer development
- Individuals are identified as trained and accessible "back ups" for each key staff and volunteer position
- Membership/donor database has the capacity to record and report all income and other revenue and to generate all needed membership documents

Residents of the greater San Diego region have services accessible to them that are based on ever-improving science and are evidence-based.

- Evidence-based program services (EBP) are described in NAMI San Diego publications
- Members of NAMI San Diego and the community are provided education about need for and benefit of EBP and are encouraged to support clinically sound research in order to improve available science

Programs

Albright Information & Referral Center

Began in 1985, this telephone helpline has become a full center featuring weekday in-office volunteers, e-mail and walk-in capacity, resources and a lending library, and evening and weekend response to voice mail. Approximately 3,600 contacts were handled during the fiscal year (FY). ☉

Family-to-Family

This NAMI program is a 12-week course for families of individuals with severe brain disorders (mental illnesses such as schizophrenia, bipolar disorder, major depression, obsessive compulsive disorder, panic disorder, and borderline personality disorder). The course is taught by trained family members. All course materials are furnished at no cost to the participants. Six classes, including one Spanish class, were taught during the FY. ☉ ☉

Peer-to-Peer

This NAMI program is a 9-week education course on the topic of recovery for any person with serious mental illness who is interested in establishing and maintaining wellness. Courses are taught by teams of three trained "mentors" who are themselves experienced at living with mental illness. Peer-to-Peer is offered free of charge to people who experience mental illness and is funded by a grant from The California Endowment during 2003 and 2004. Twelve new mentors were trained and five classes were held during the FY. ☉

Schizophrenia: Education for Families & Caregivers

Presented by NAMI San Diego and County of San Diego Health & Human Services Agency, Adult and Older Adult Mental Health Services, and Sharp Mesa Vista Hospital, this six-week lecture series educates families and others about the no-fault biological illness, the possible paths to re-

covery, and the ways in which families can help. Four series, including one in Spanish, were presented during the FY.

In Our Own Voice: Living with Mental Illness

A very powerful and compelling program, IOOV is an informational outreach program on recovery presented by trained consumers to other consumers, families, students, professionals, and all people wanting to learn about mental illness. Forty-six presentations were made during the FY to 673 people and 14 new presenters were trained.

NAMI Support Groups & NAMI C.A.R.E.

Support is the first thing that the founders of NAMI San Diego supplied to each other more than 26 years ago and it is still a cornerstone of our organization. NAMI has both open support groups facilitated by trained family members and consumer groups (NAMI C.A.R.E.) facilitated by consumer peers. Eight open groups, one in Spanish, ☉ met regularly during the FY and 51 ☉ C.A.R.E. sessions were held. Thirteen new C.A.R.E. facilitators were trained. ☉

Task Forces

Three task forces formed and began meeting regularly during the FY to help NAMI take its programming into the communities represented by those groups in an effective way. The Latino Task Force helped translate the fact sheets into Spanish and began planning to recruit bilingual, bicultural volunteers. The Children's Task Force set goals of family support, school outreach, and parent education. The African American Task Force began working with the faith community. ☉

Silver Anniversary Dinner & Silent Auction

NAMI San Diego celebrated its 25th anni-

versary at Tom Ham's Lighthouse in October, 2003. Carol LeBeau received the Silver Anniversary Community Service Award. Henry (Hank) Teisher was recognized for his role as one of NAMI's founders.

Walk for Wellness: Strides for Mental Health

NAMI San Diego's 5th annual walk & resource fair was held in Balboa Park on April 17, 2004. Approximately 500 people participated. ☉

First Contact

The First Contact program was launched to make illness and NAMI information available to non-psychiatric providers. With the help of the Beyster Family Foundation and Marjorie & Arden Joramo, 350 packets were printed and distributed. ☉

Project Payee

Funded by a contract with County Mental Health, Project Payee provided representative payee services to 100 clients each month.

CARE Representative Payee

Emergency Assistance Resource Pools (EARP)

Partial Assistance Rent Subsidy

Funded by the Ryan White CARE Act through the County's Office of AIDS Coordination for people who are HIV+ and are likely to have mental health problems, the representative payee program provided services to 98 individuals, the emergency pools to 1,120, and PARS to 425.

Intensive Case Management Support

The ICM program is funded principally by Housing Opportunities for Persons with AIDS. NAMI provides fiscal management.

Developed by: American Association of Fund Raising Counsel, Association for Healthcare Philanthropy, Council for Advancement and Support of Education and National Association of Fund Raising Executives

PROP 63 INFORMATION

California voters approved Proposition 63 on November 2nd so all we have to do now is open up our pockets and wait for the money to flow in - right? You know, of course, that things do not happen that easily. In fact, it seems there is at least as much work to do when things are going “right” as when they are going “wrong”.

County Mental Health Services and the County Mental Health Board are proposing that three community organizations actively work on implementing the Mental Health Services Act (Prop 63’s real name) to assure full community understanding and input. The Children’s System of Care Steering Committee, an *ad hoc* committee for the adult system, and the Older Adult Task Force are developing plans for carrying out their charge. NAMI is a part of the groups. When approved by the Board of Supervisors, this strategy for obtaining “stakeholder” input will be included in a Plan for Planning submitted by County Mental Health Services to State Department of Mental Health. We will keep you informed of opportunities to participate in this process in this newsletter and on our website. *The first year’s timeline is on the back of this information page.*

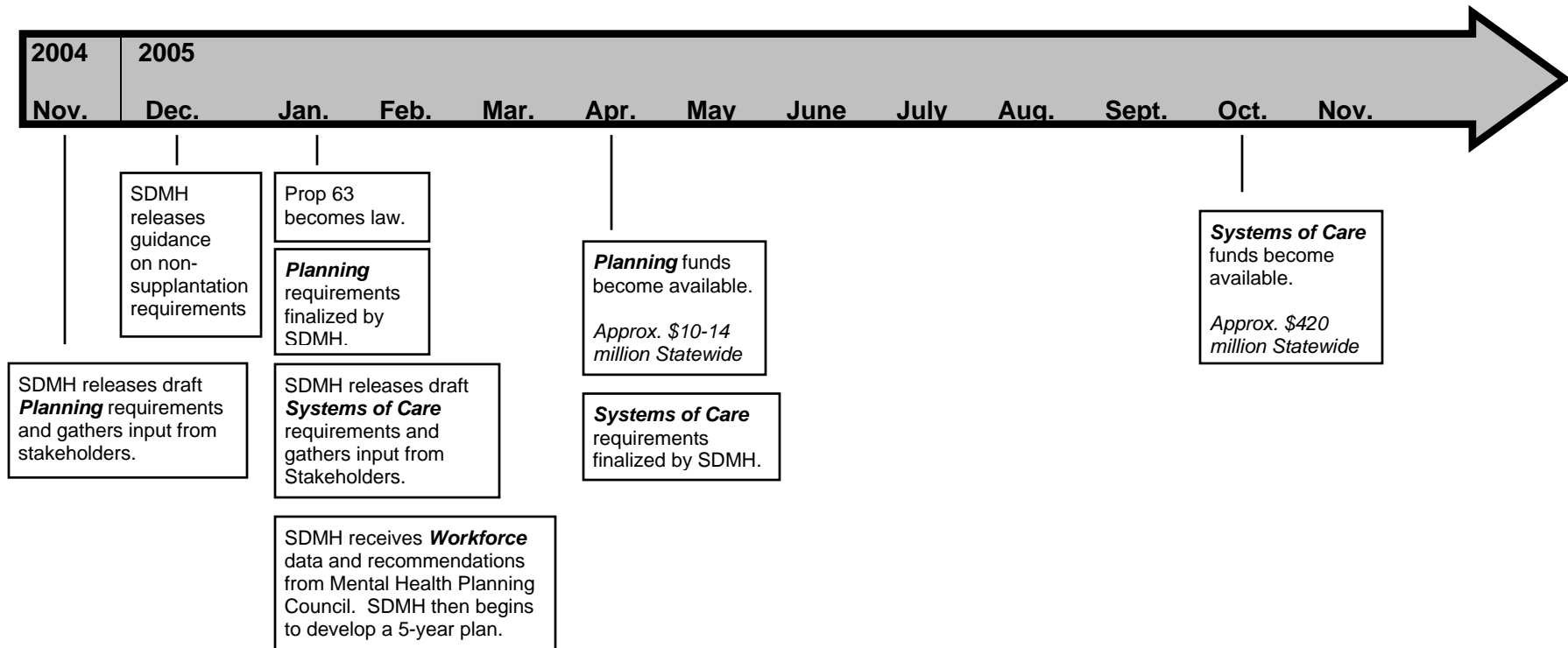
