Local and State regulations require all food workers to be trained in Food Safety. Food Handlers must obtain a County required Food Handler Certificate and State Law requires a Food Safety Certificate holder in each food facility. The Food Handler Courses are authorized by the County and are listed below. The State required certificate is offered by one of the four companies listed below. Please contact them directly for course locations and information.

Food Safety Certificates and Food Handler Cards are valid for 3 years from date of issue. The Food Handler schools listed below are monitored by the County of San Diego for course content and consistency.
