### **“Do Not Drink” and “Boil Water” Orders in San Diego County**

A “Do Not Drink” order was issued by the California Department of Public Health for the Ramona Municipal Water District. Last night, Ramona residents were contacted via reverse 911 calls and urged to drink bottled water only, and not to turn on water in homes or businesses until further notice. Bottled water is available for Ramona residents at Ramona Rodeo Grounds at 434 Aqua Lane.

A “Boil Water” order was issued for the Rainbow Municipal Water District, located north of Highway 76. As a safety precaution, residents are being advised to use boiled tap water or bottled water for drinking and cooking.

Five additional “Boil Water” orders and public notifications were issued last night by the County of San Diego, Department of Environmental Health for the following public water systems which lost pressure due to the fires. Boil Water Orders will remain in effect until systems have been disinfected and water samples confirm absence of bacteria.
