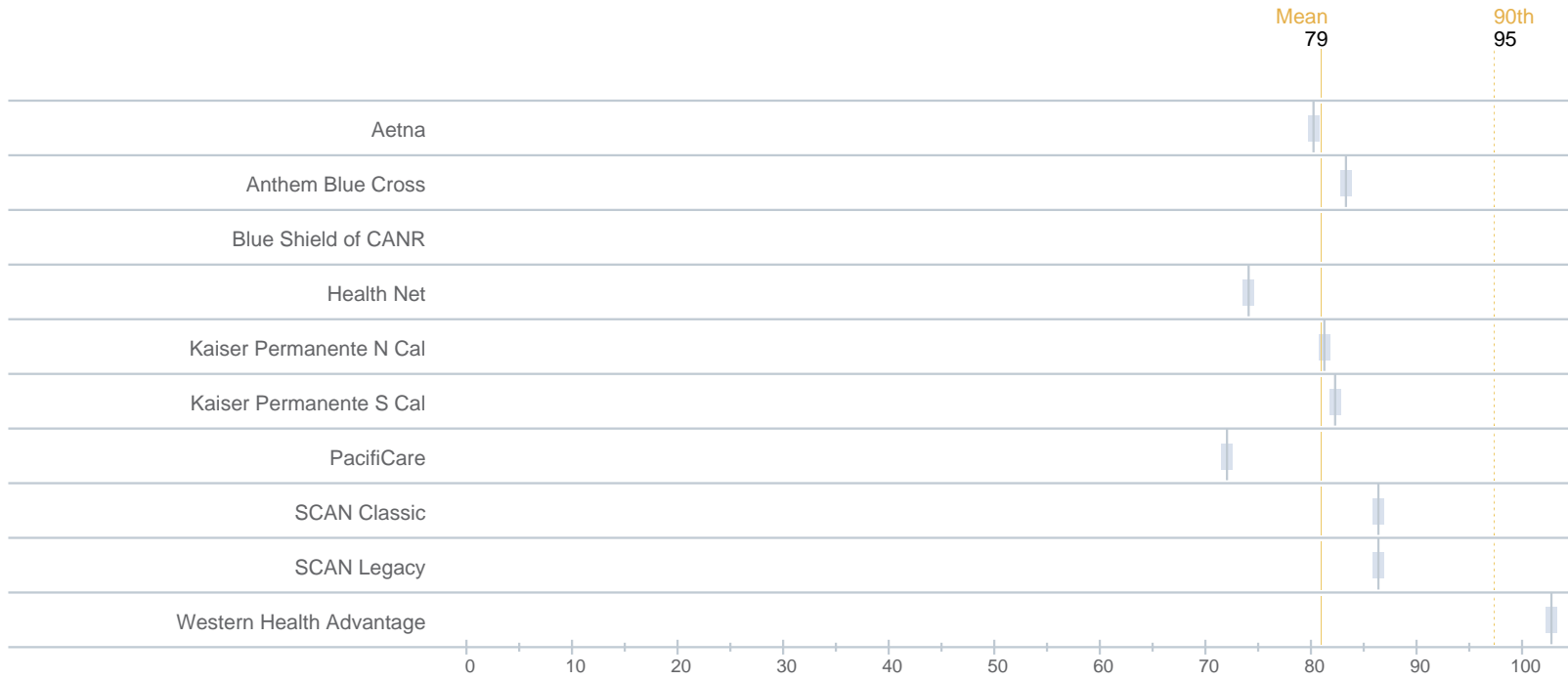

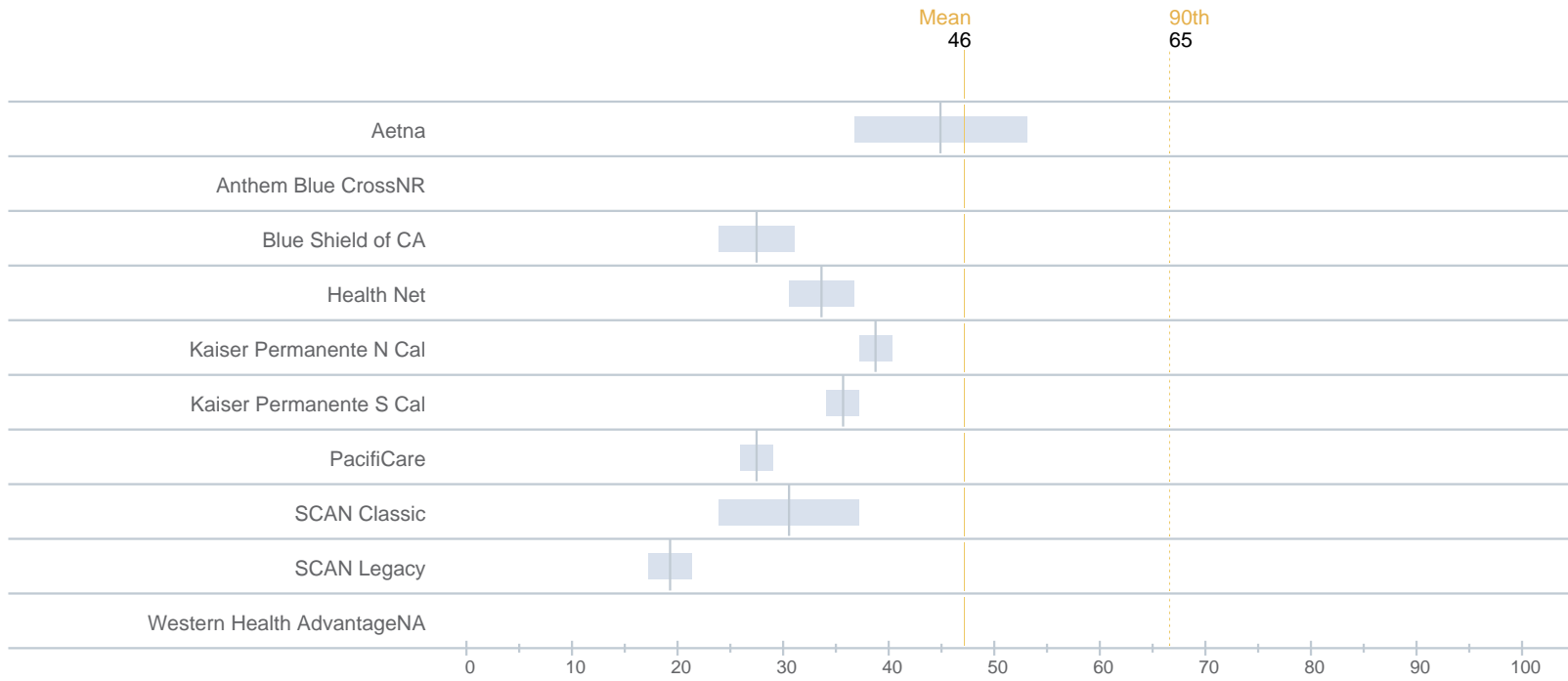

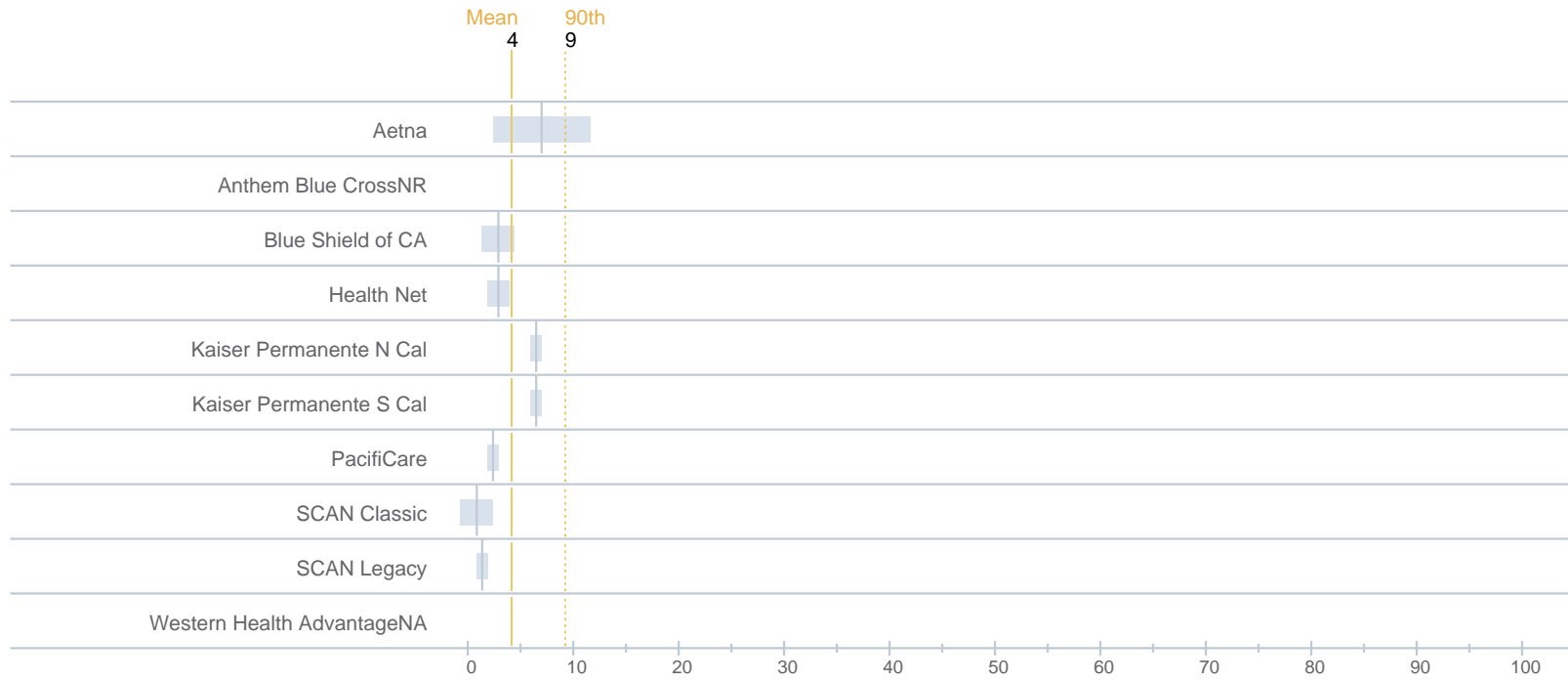
Alcohol and Other Drug Dependence Treatment: Initiation - Total

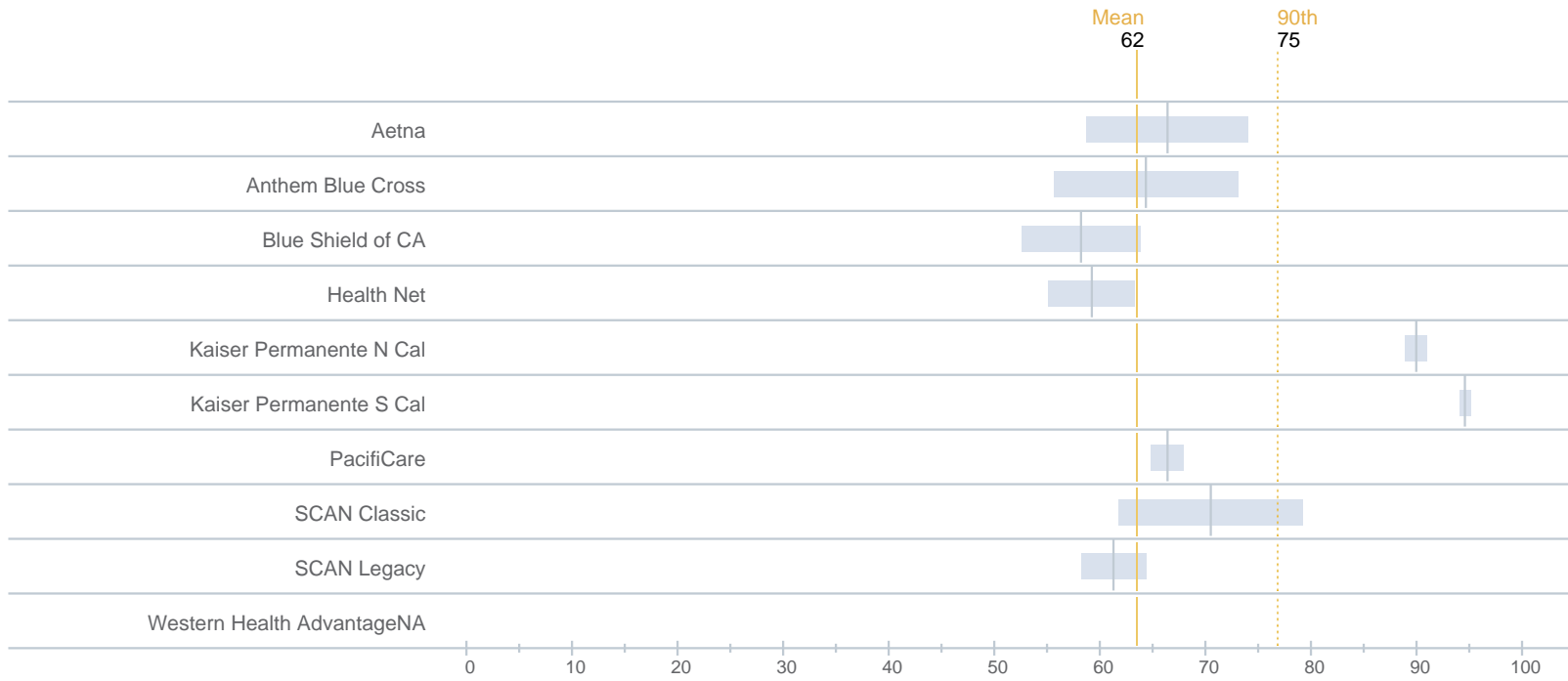

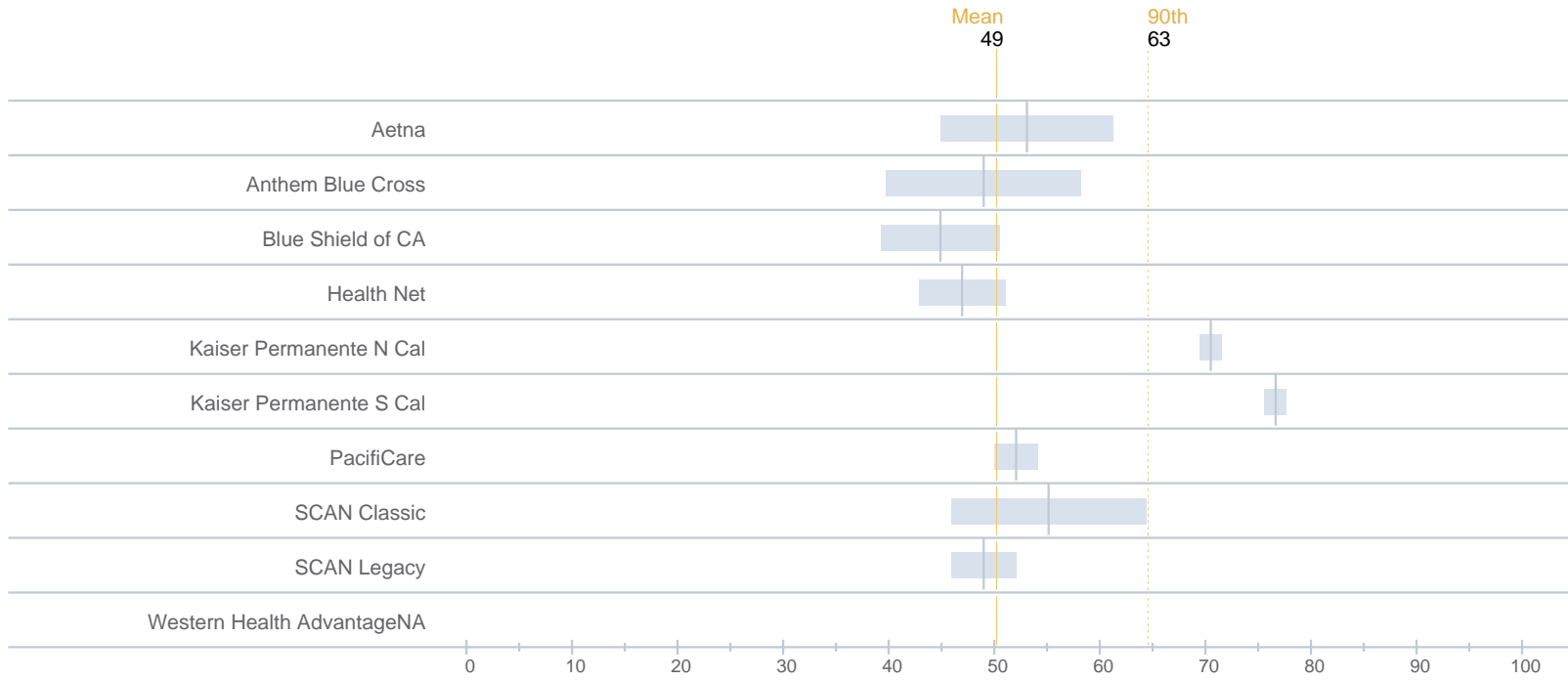
### Antidepressant Medication Management: Effective Acute Phase Treatment

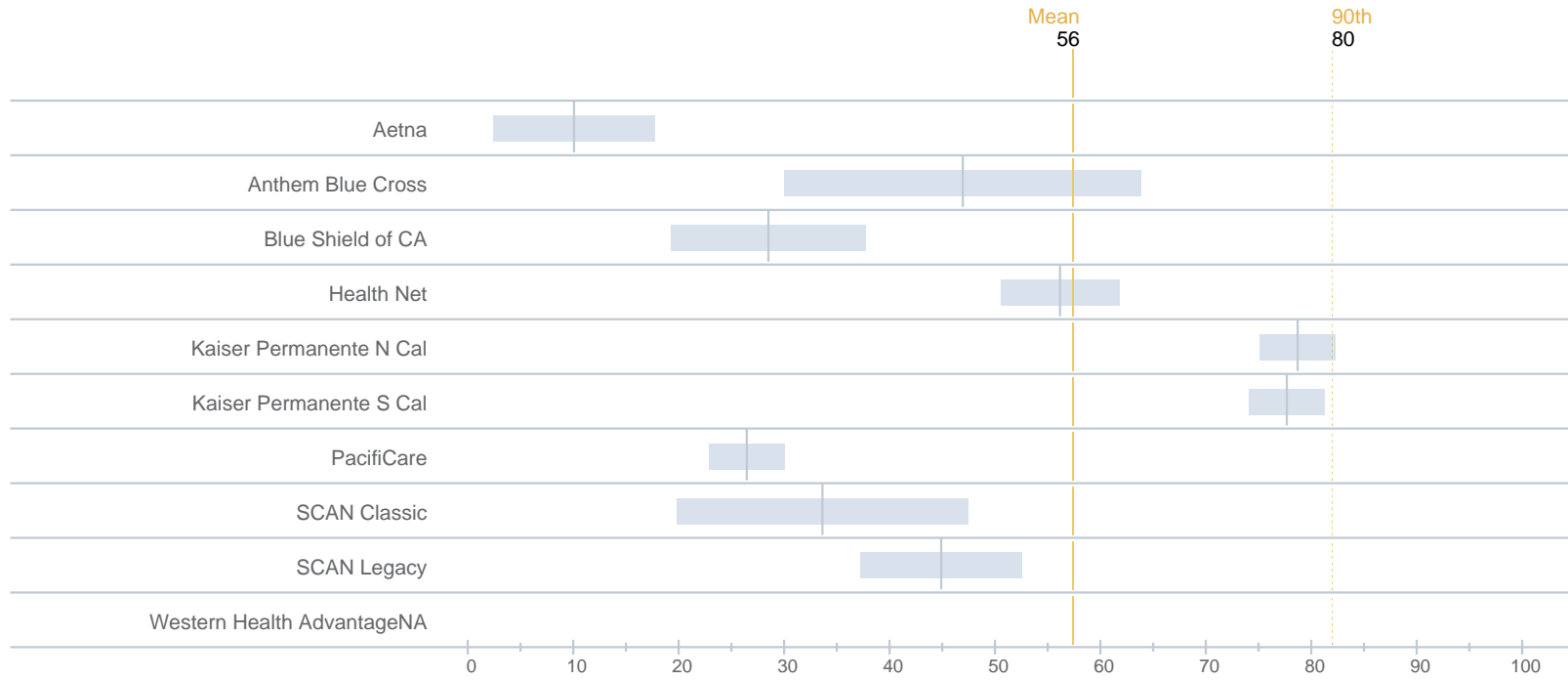

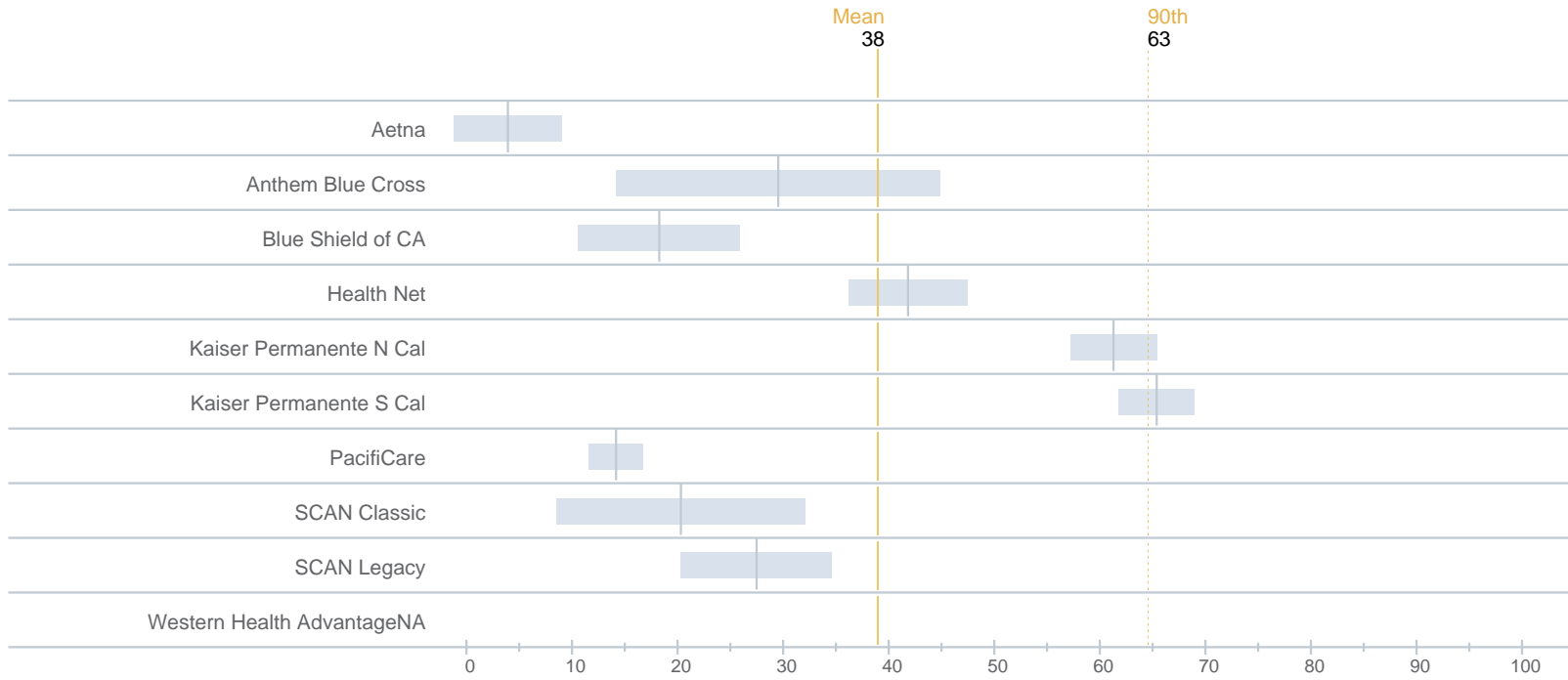
### Follow-up After Hospitalization for Mental Illness: Follow-up within 30 days of hospital discharge

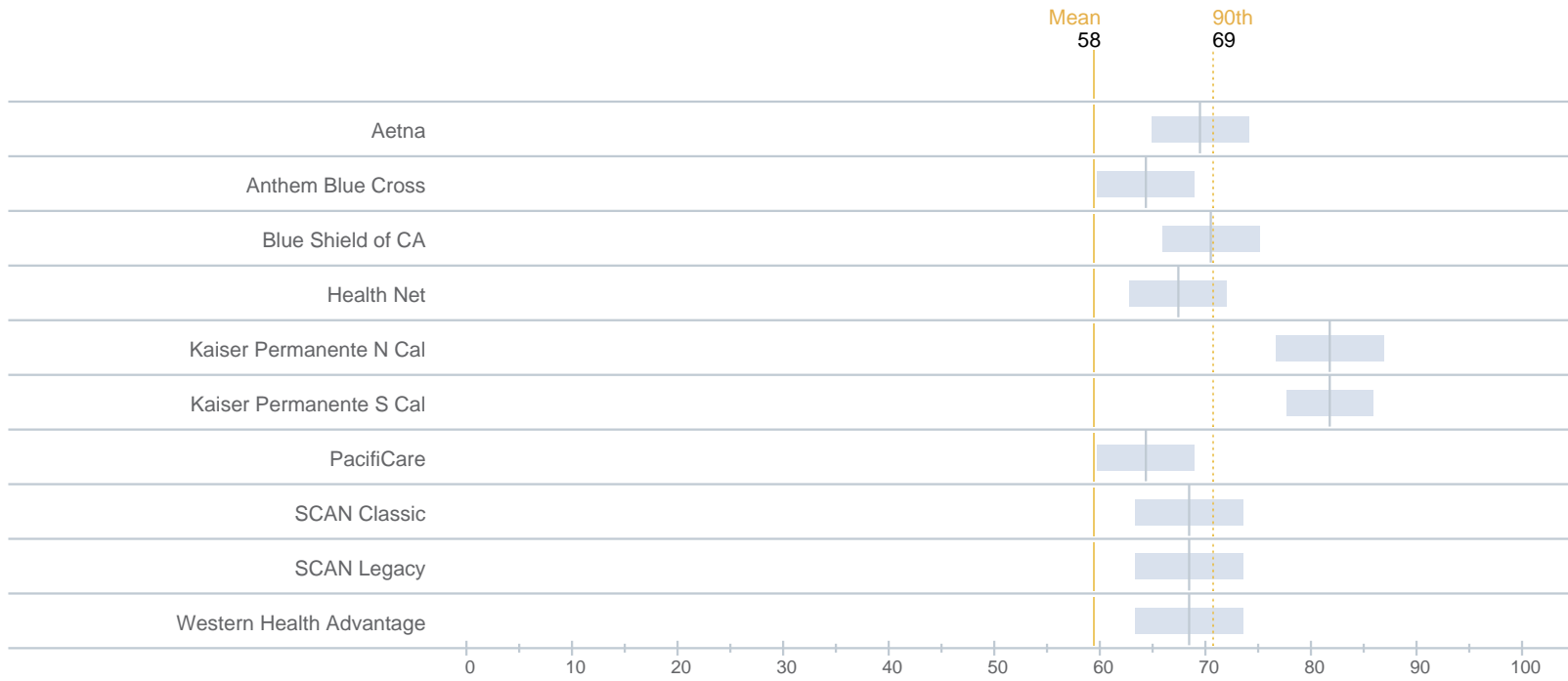

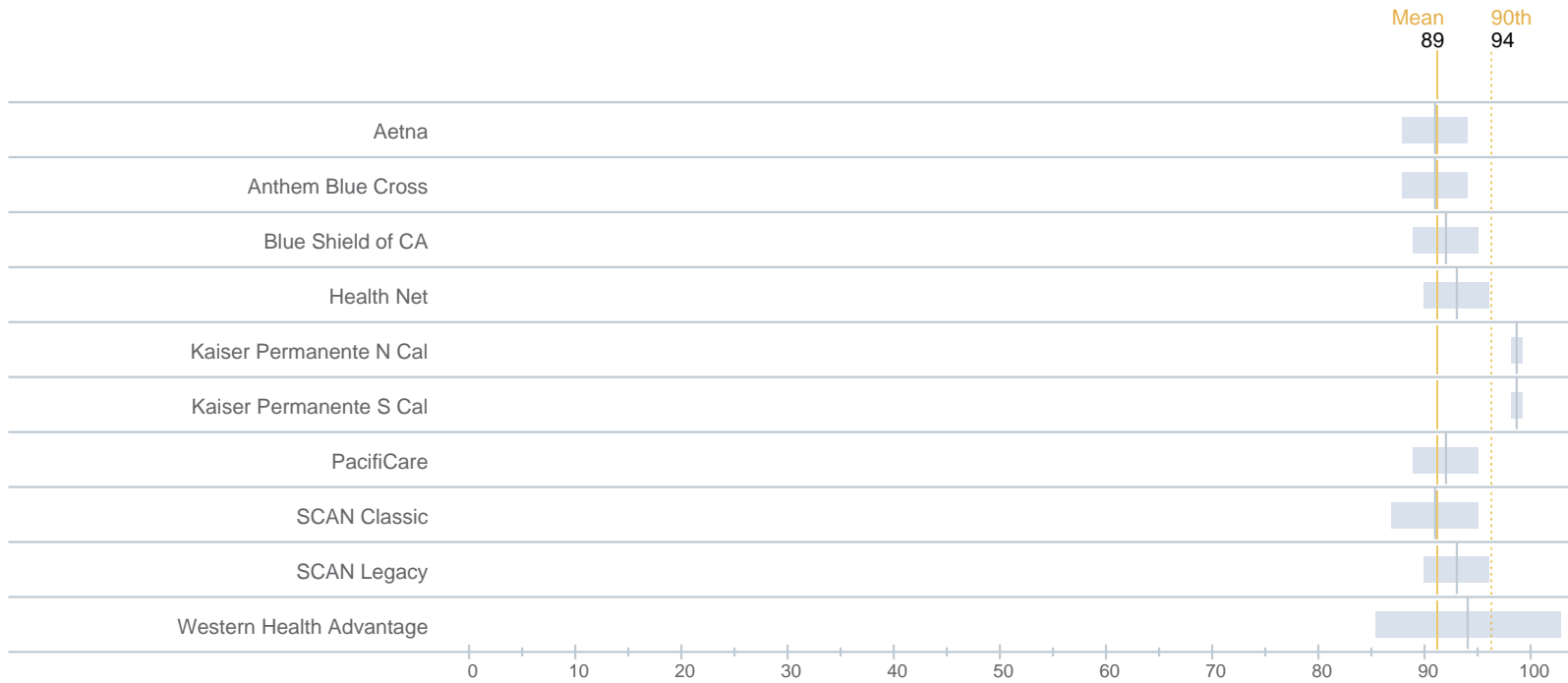
Controlling High Blood Pressure

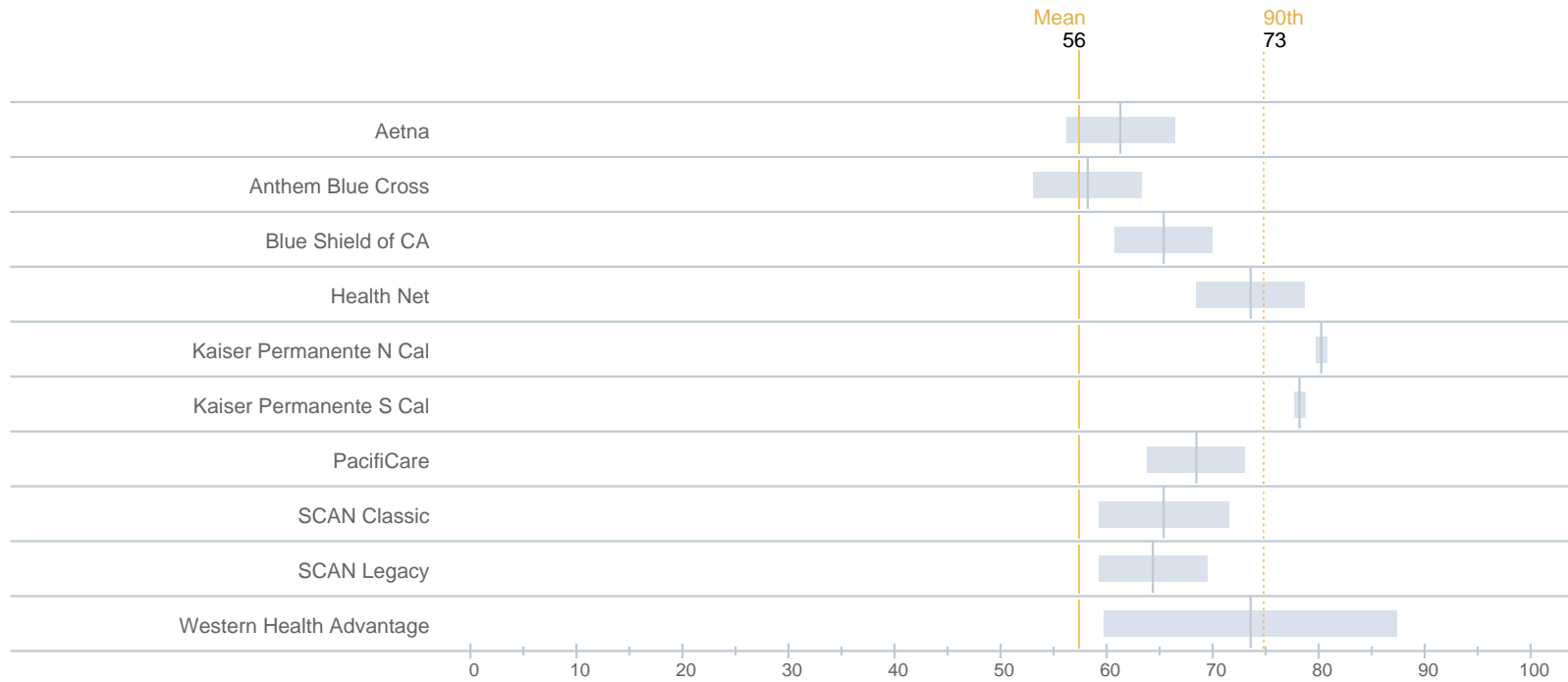

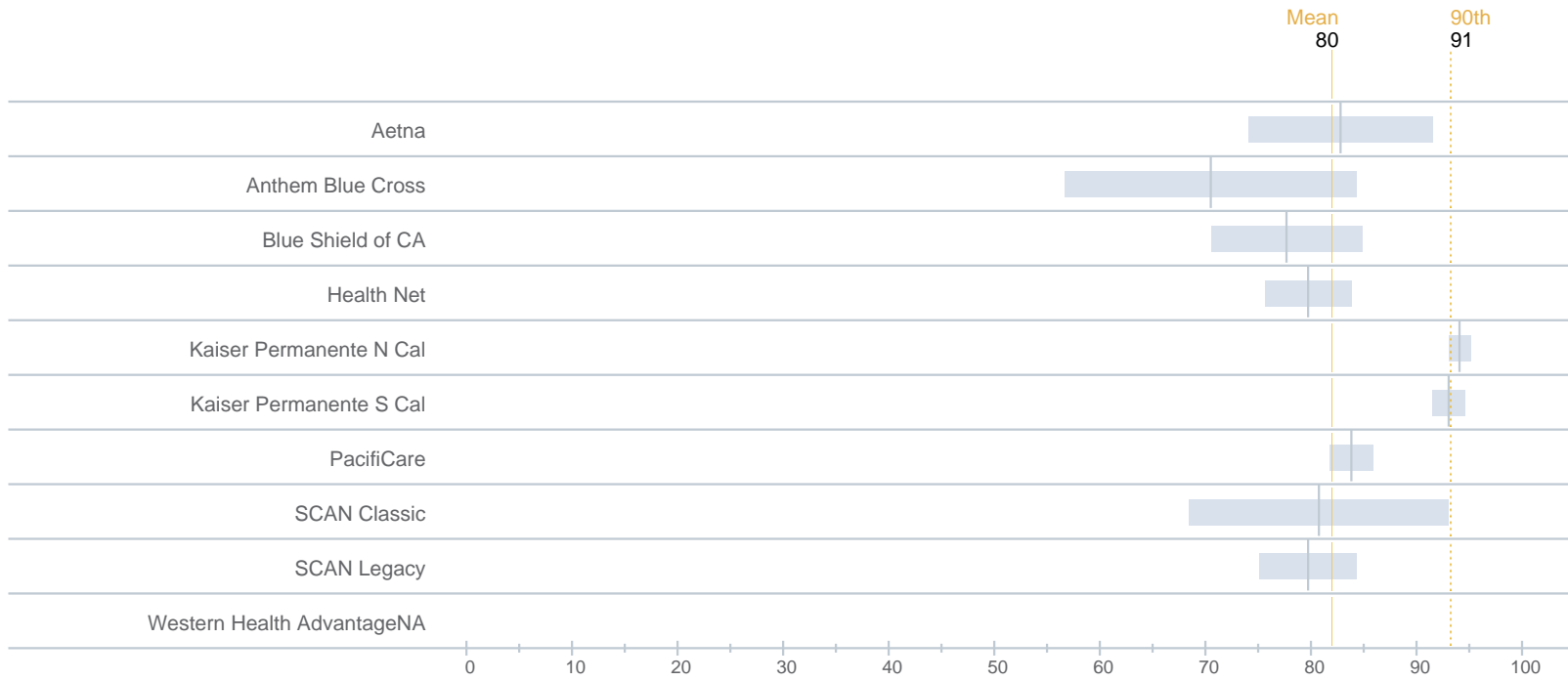

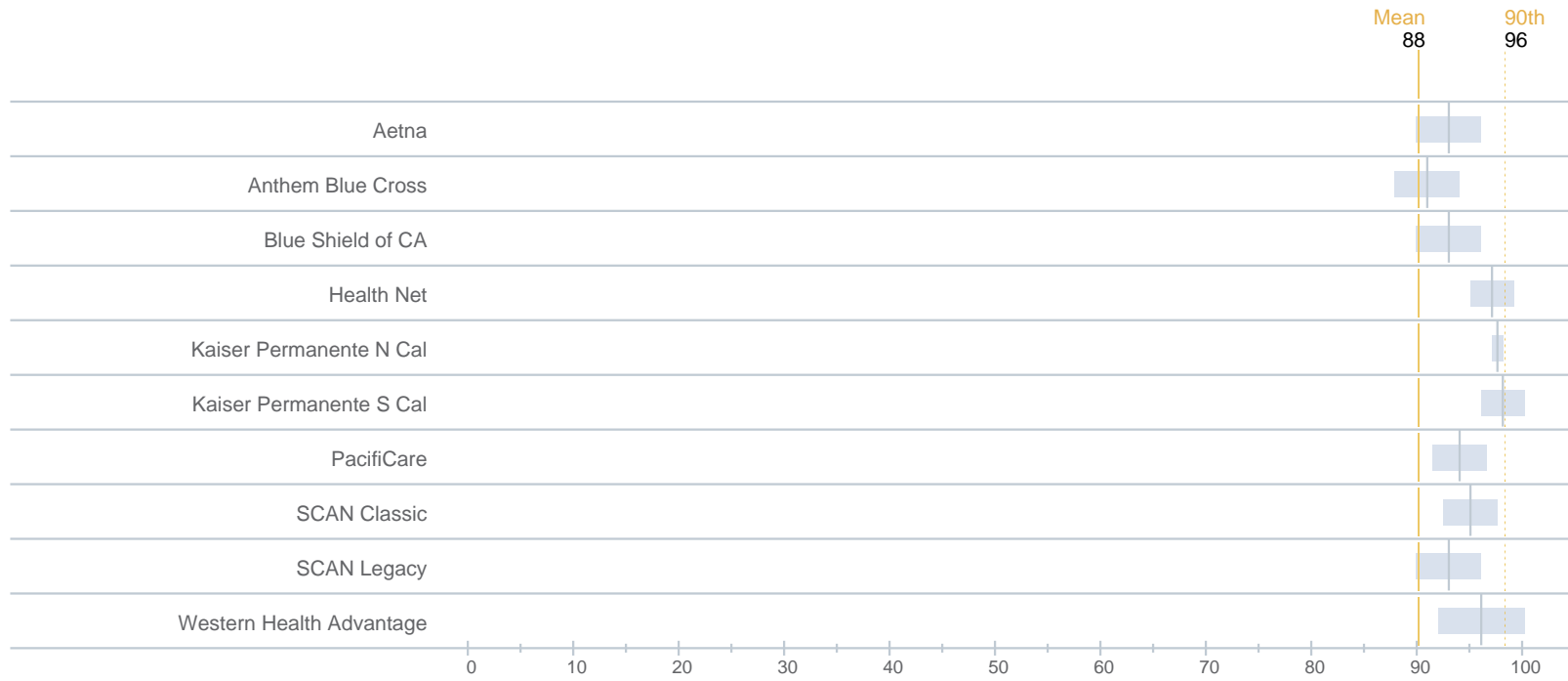
Persistence of Beta-Blocker

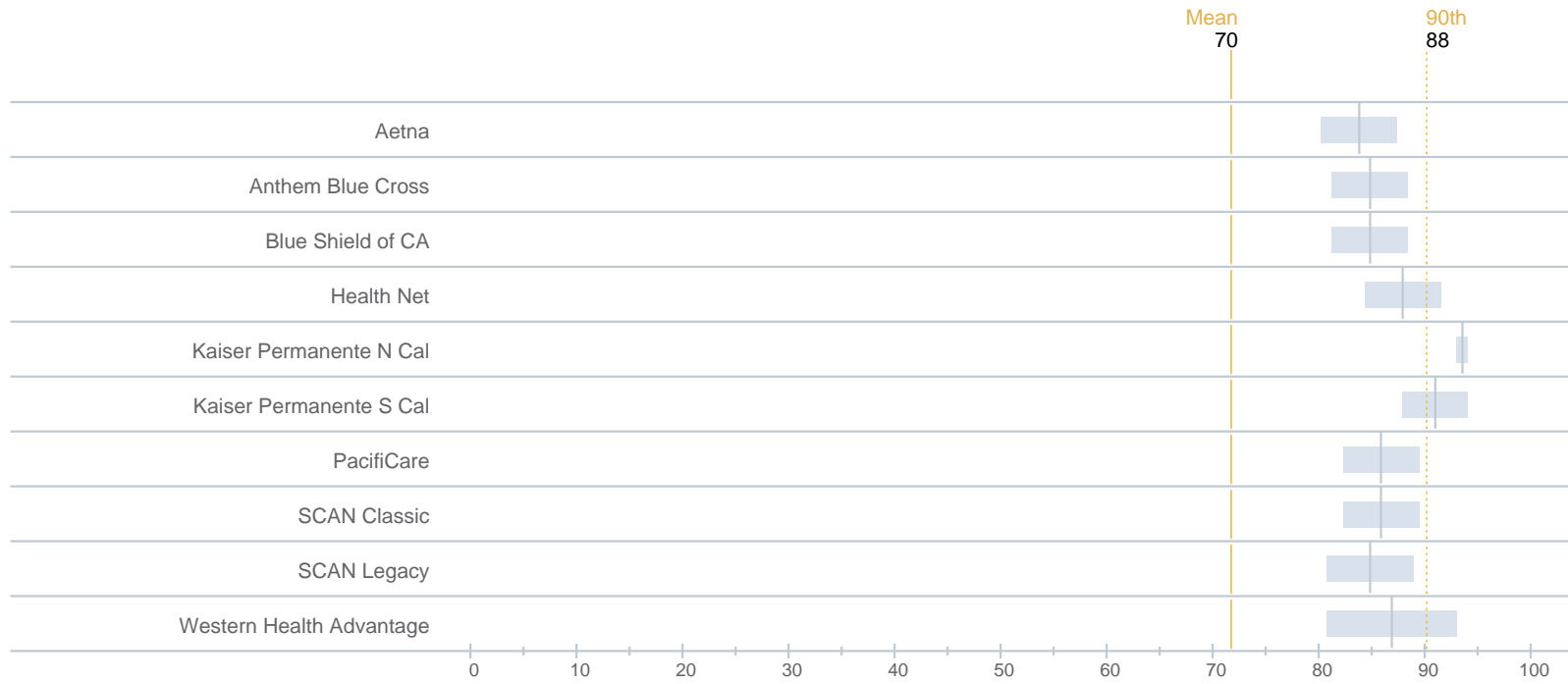

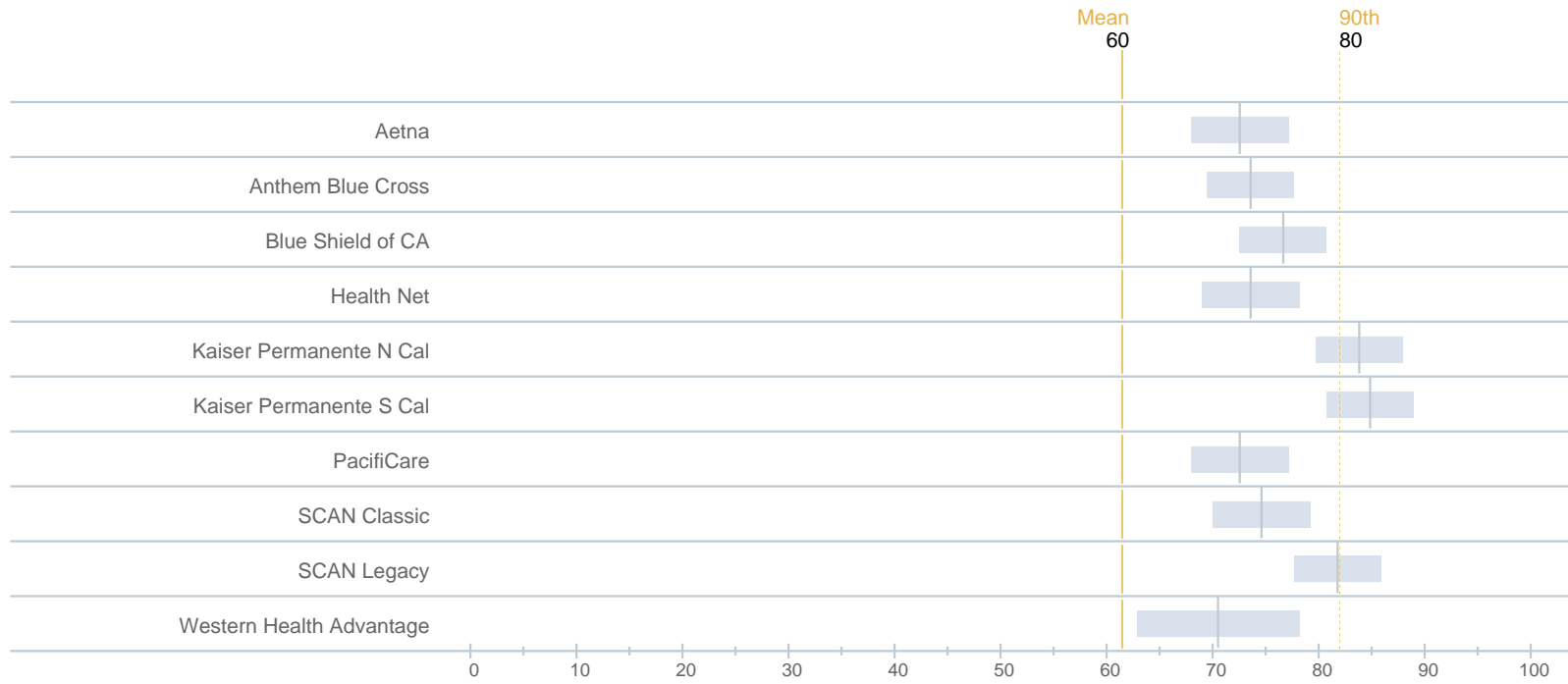

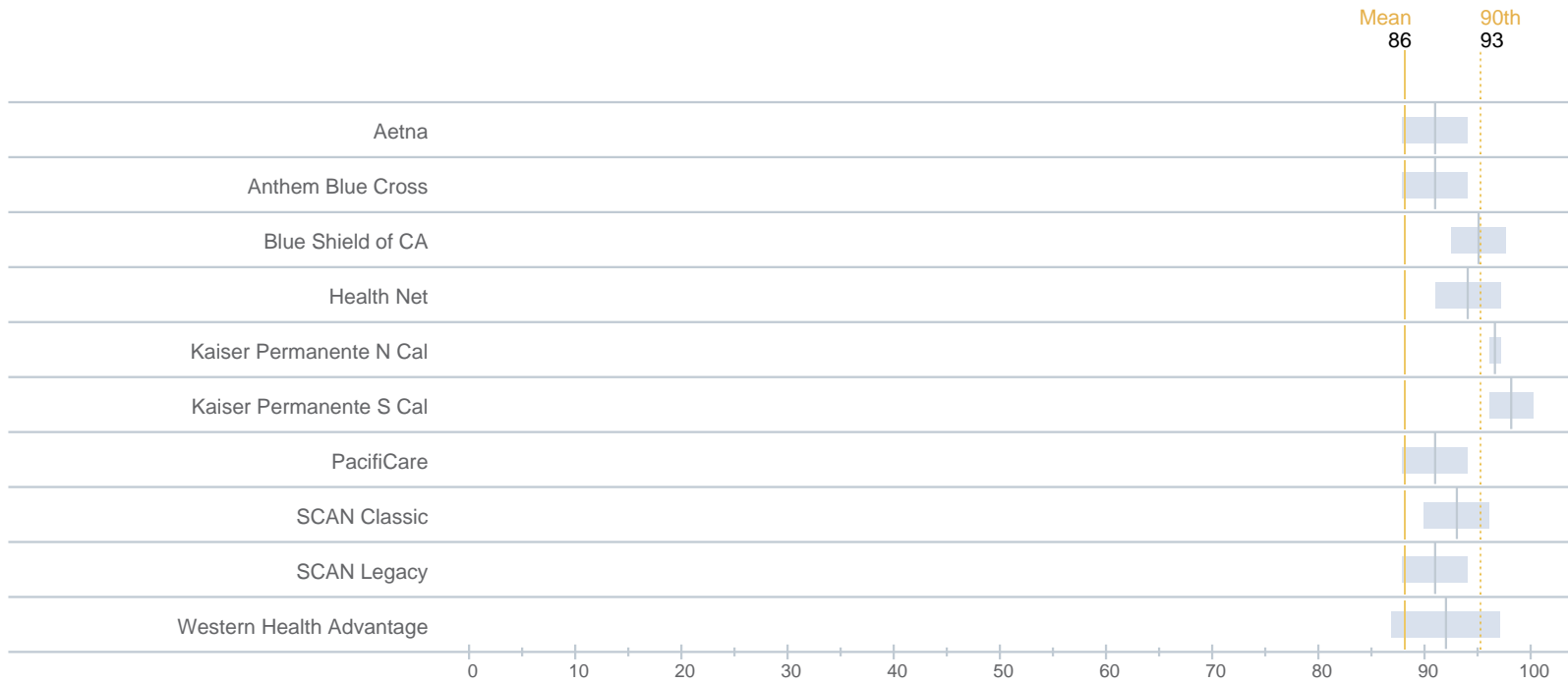

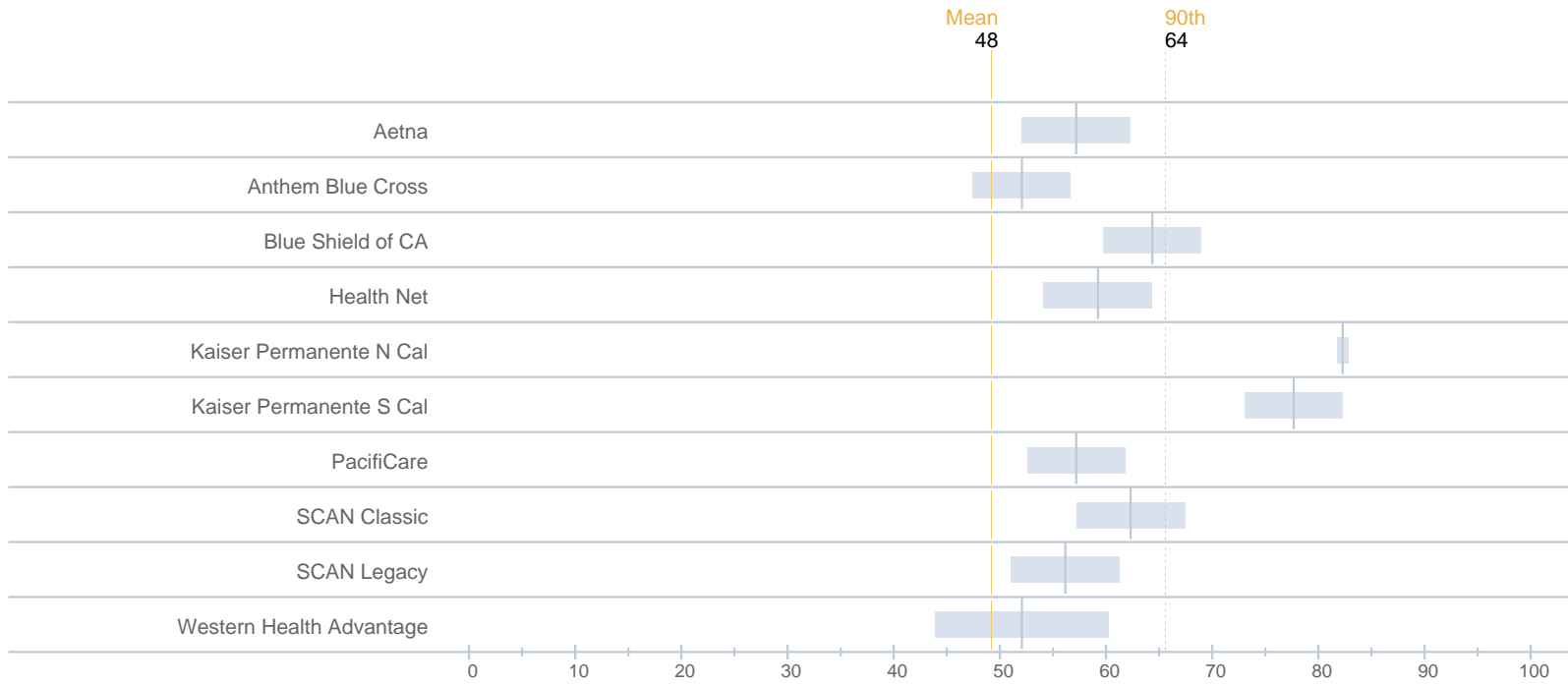

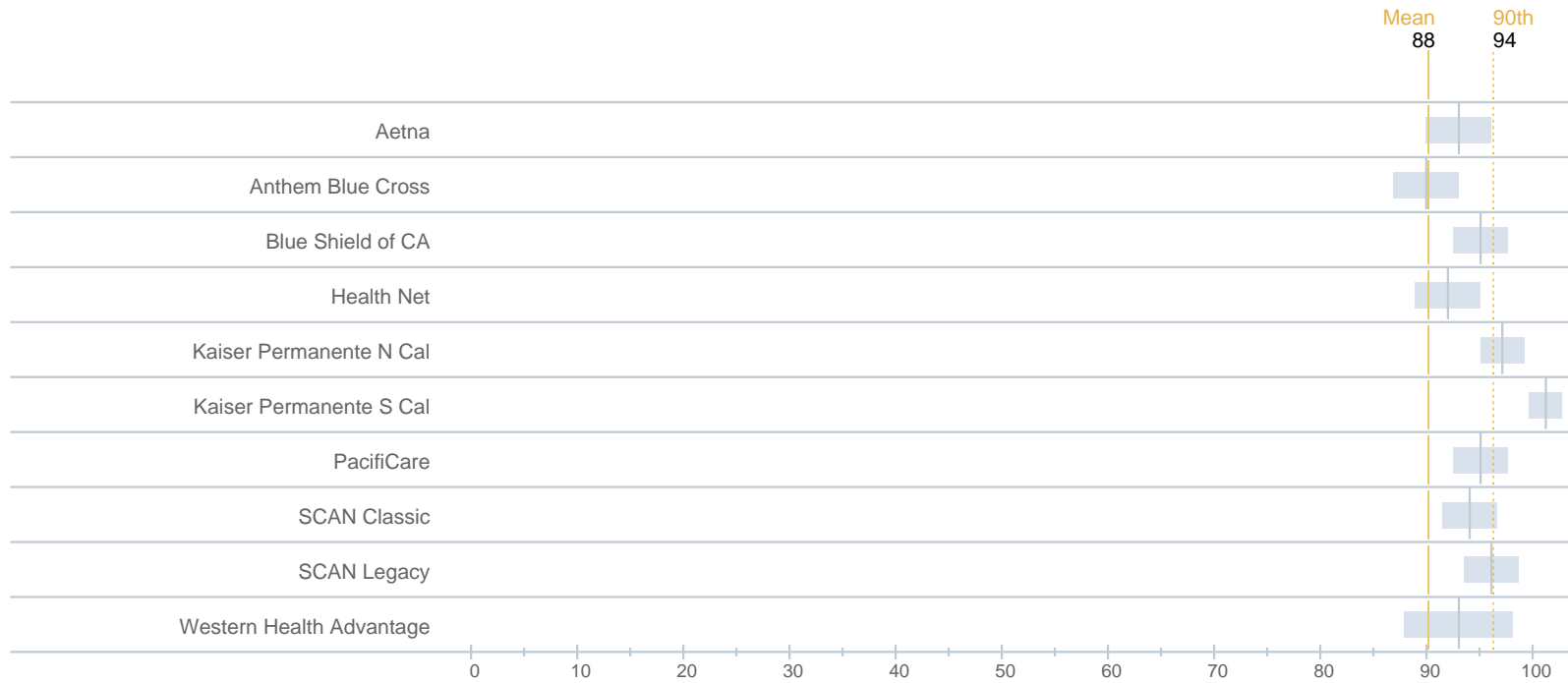

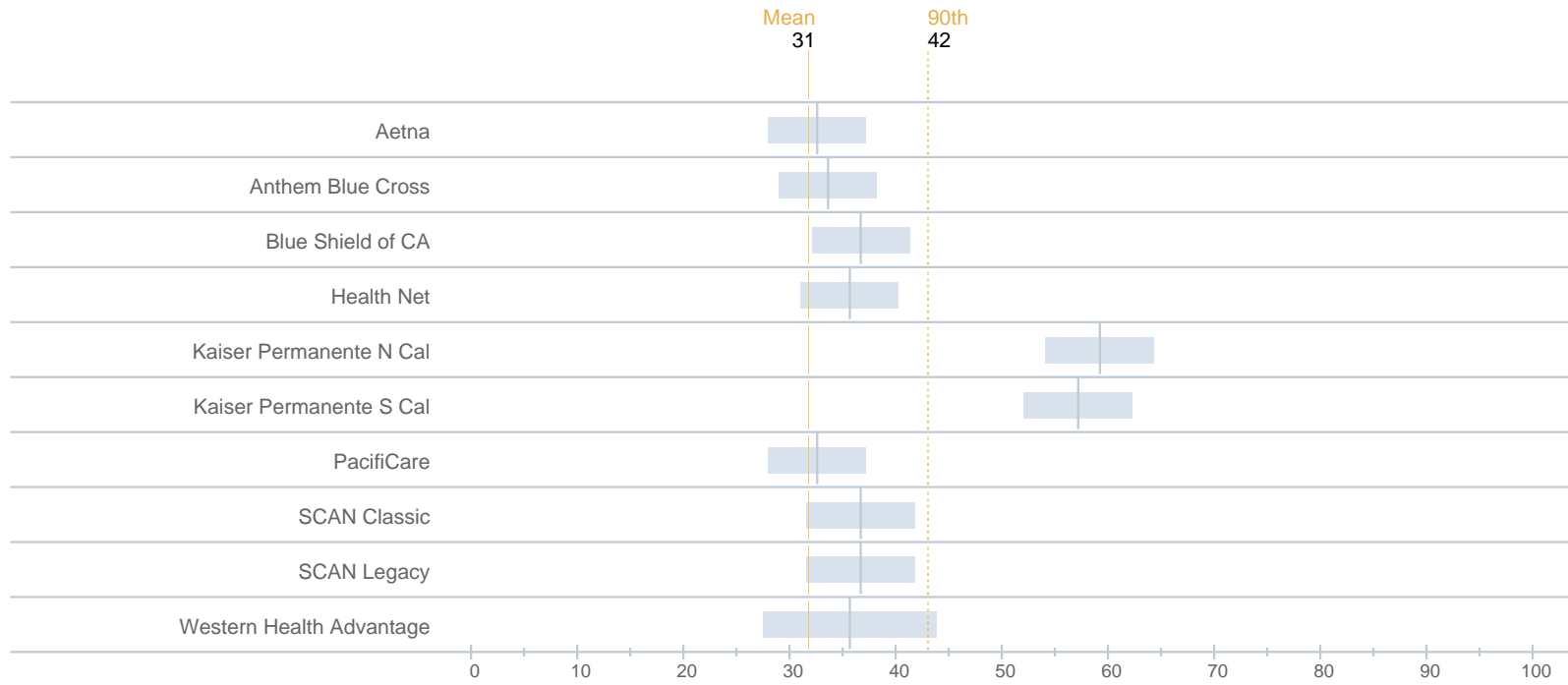

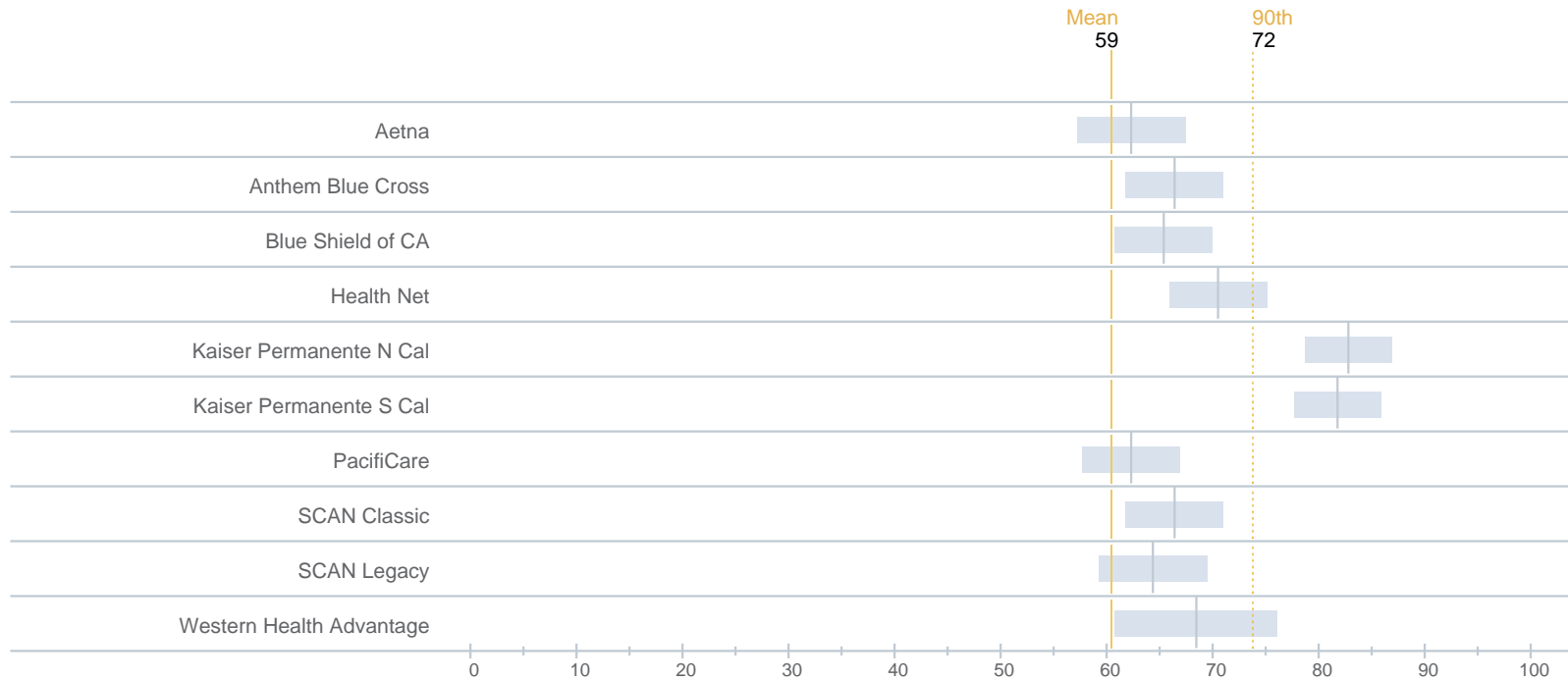

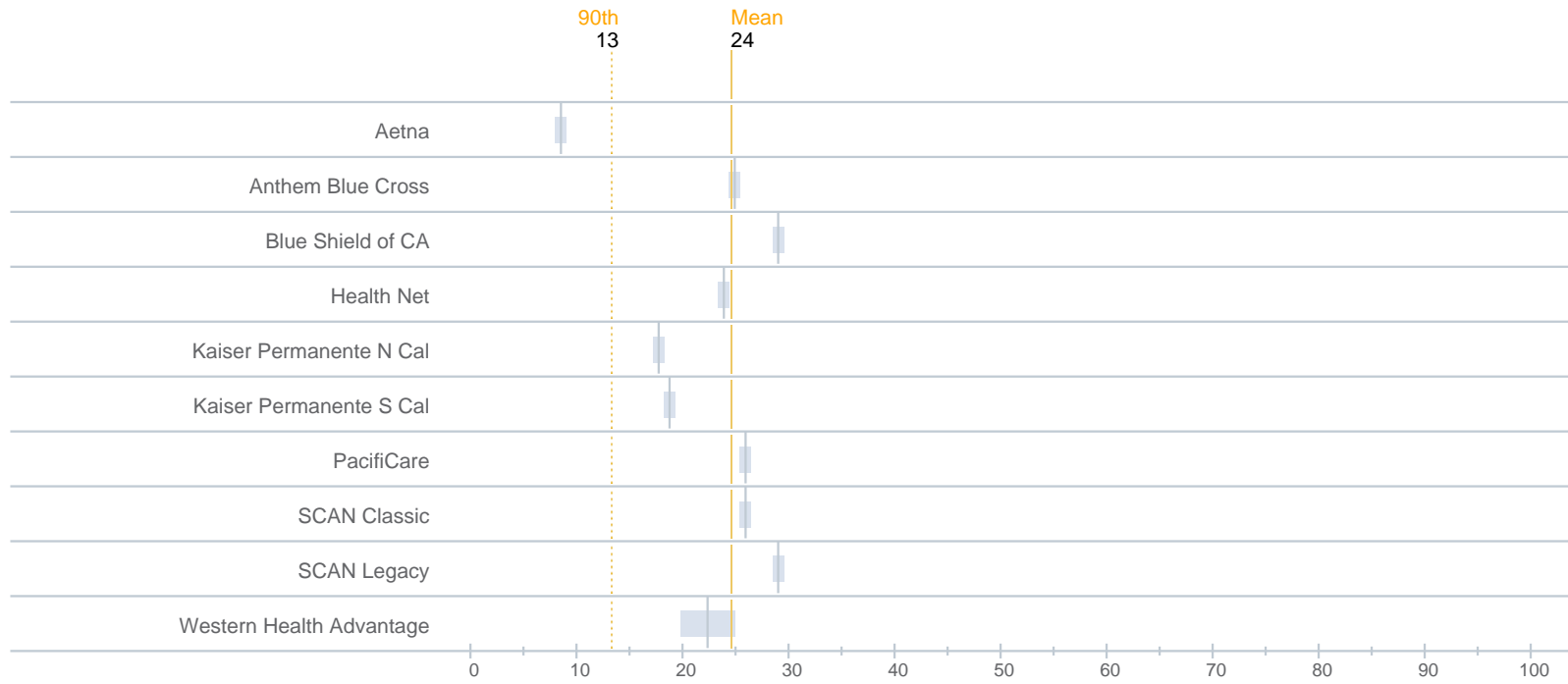

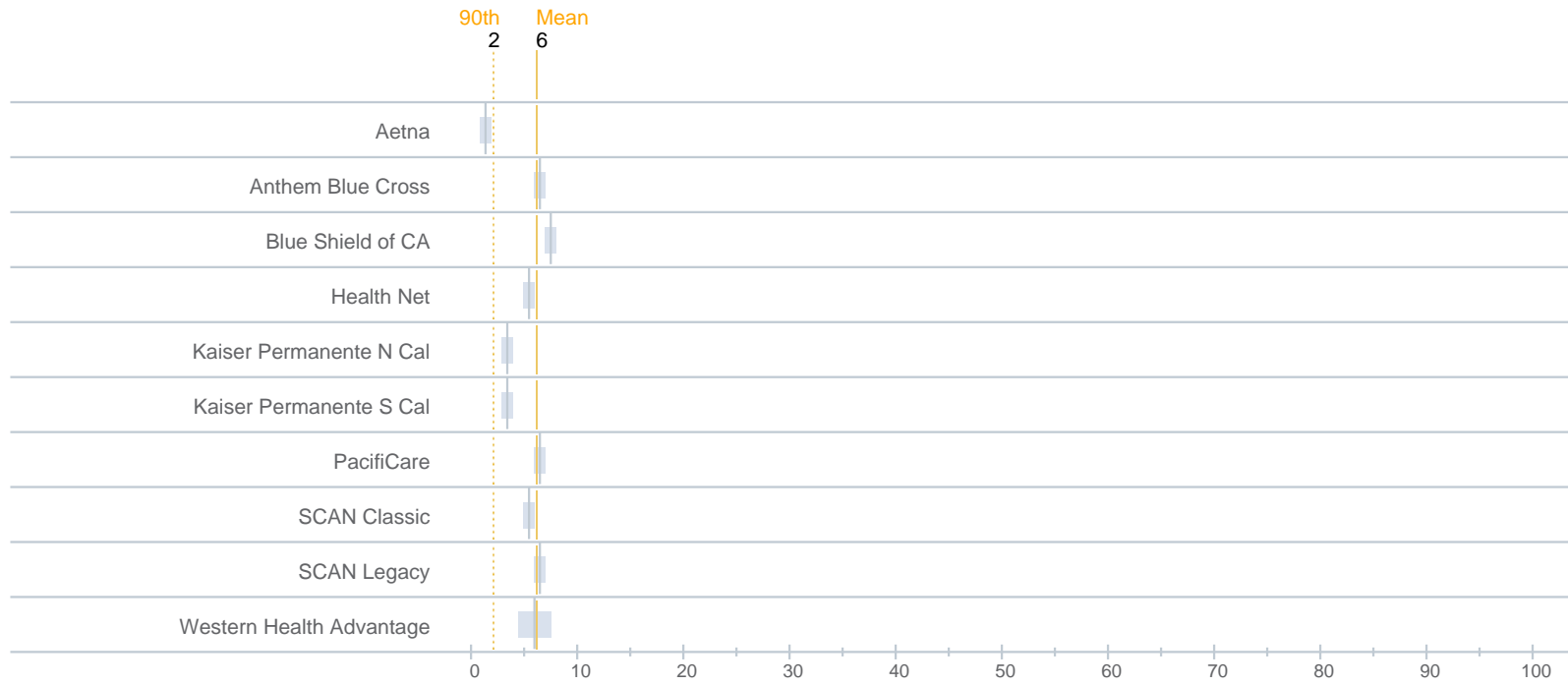
Use of High-Risk Medications in the Elderly: One Prescription<sup>a</sup>

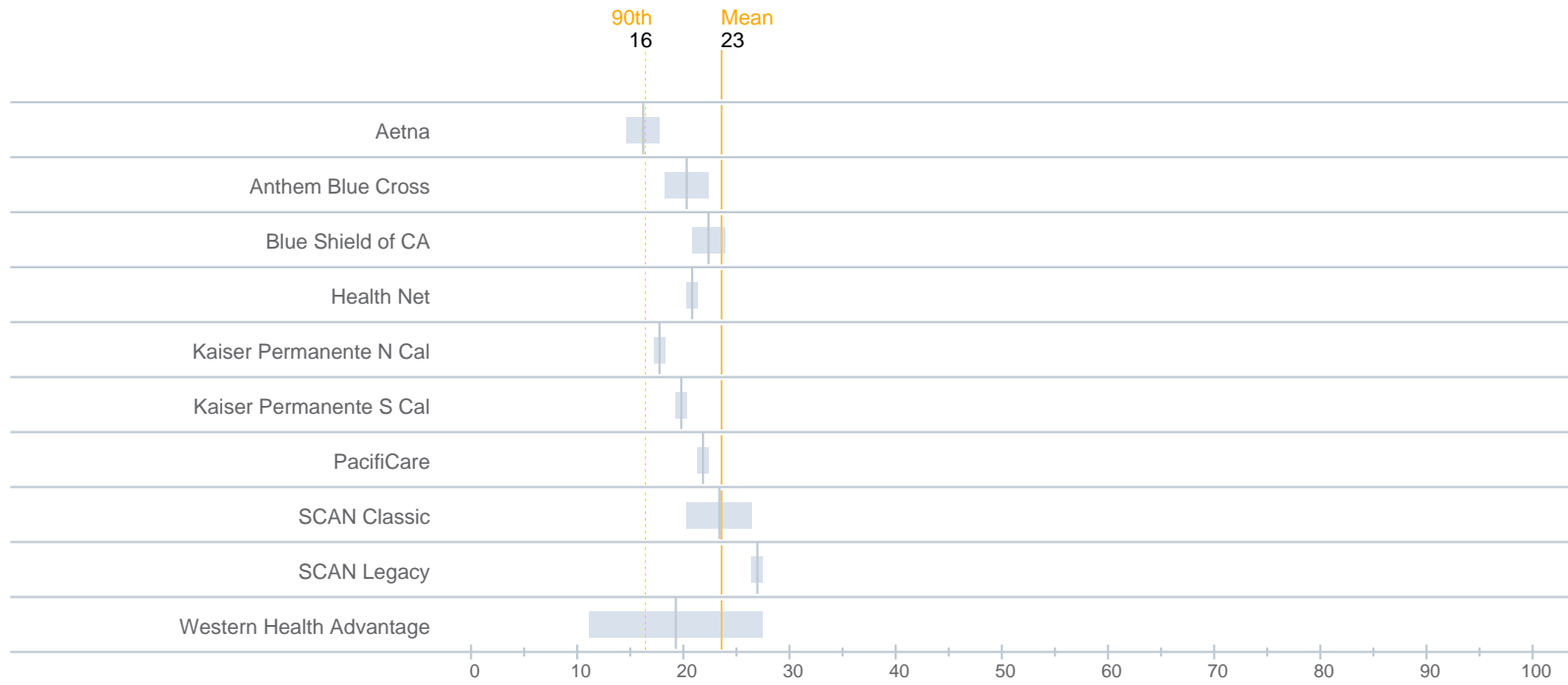
Use of High-Risk Medications in the Elderly: Two or More Prescriptions<sup>a</sup>

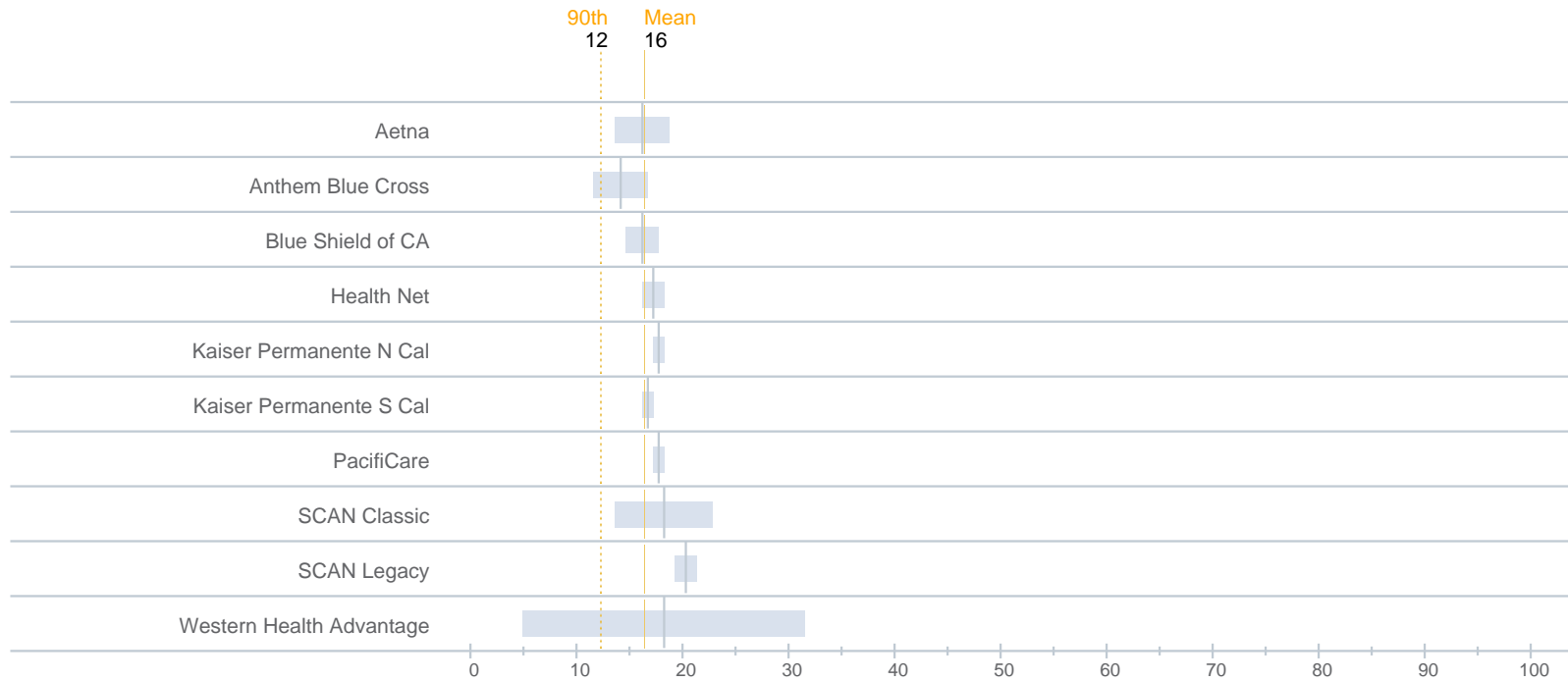
Potentially Harmful Drug-Disease Interactions: Total<sup>a</sup>

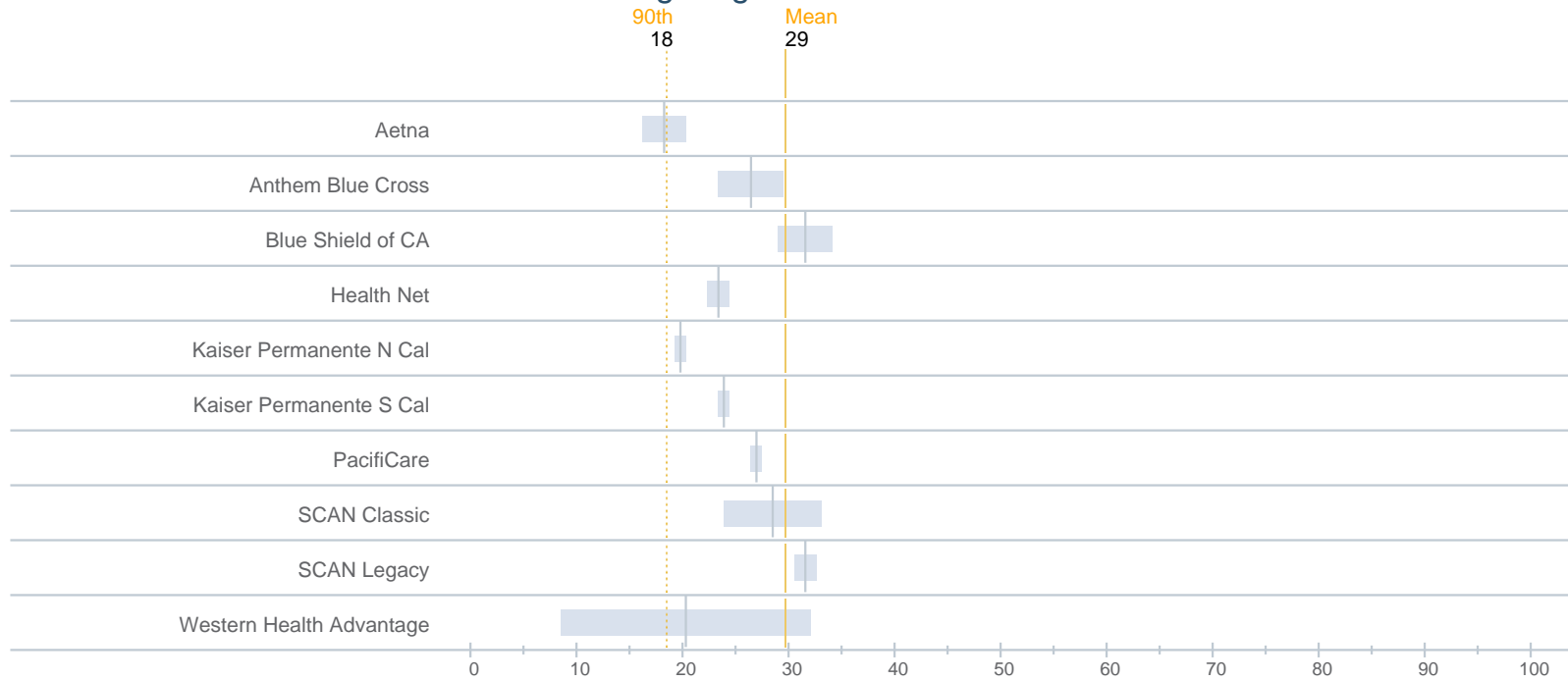

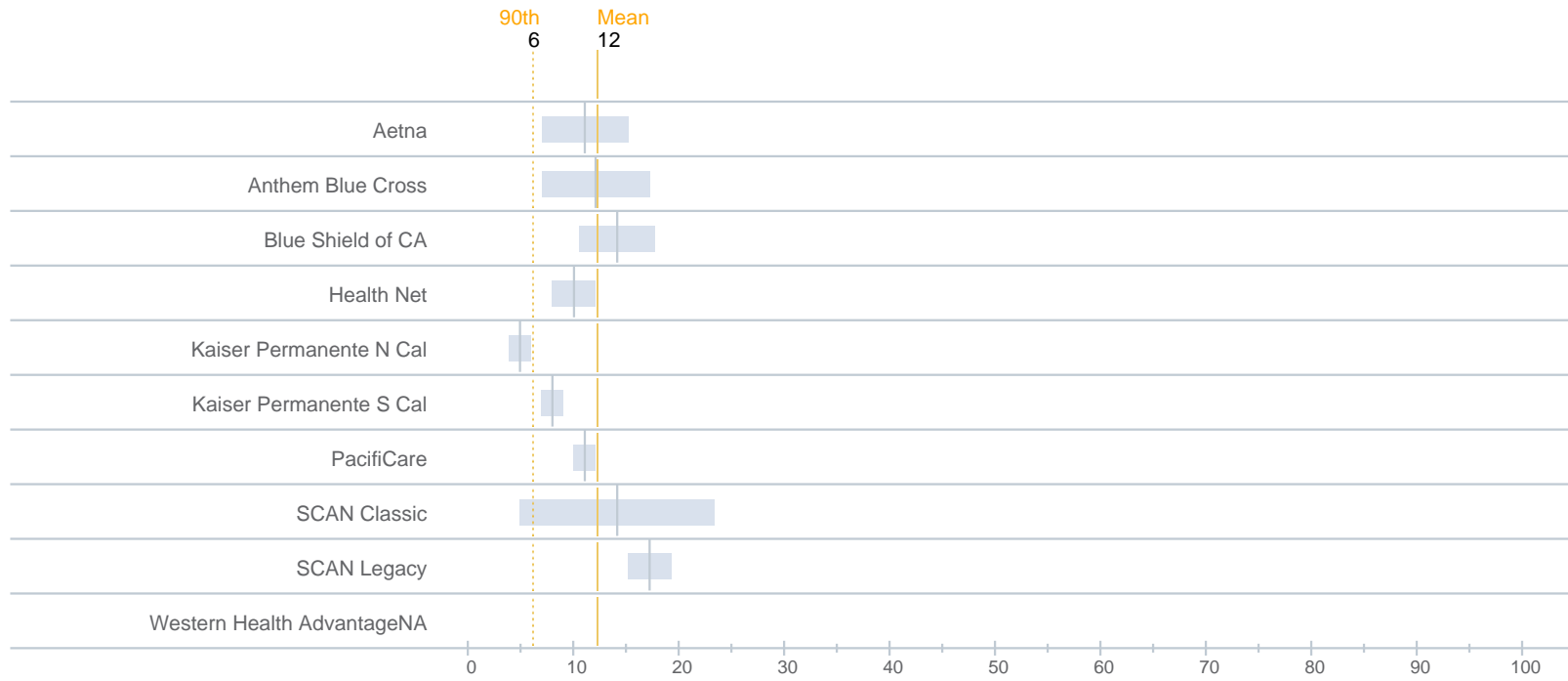
Potentially Harmful Drug-Disease Interactions: Dementia + Tricyclic Antidepressants or Anticholinergic Agents<sup>a</sup>

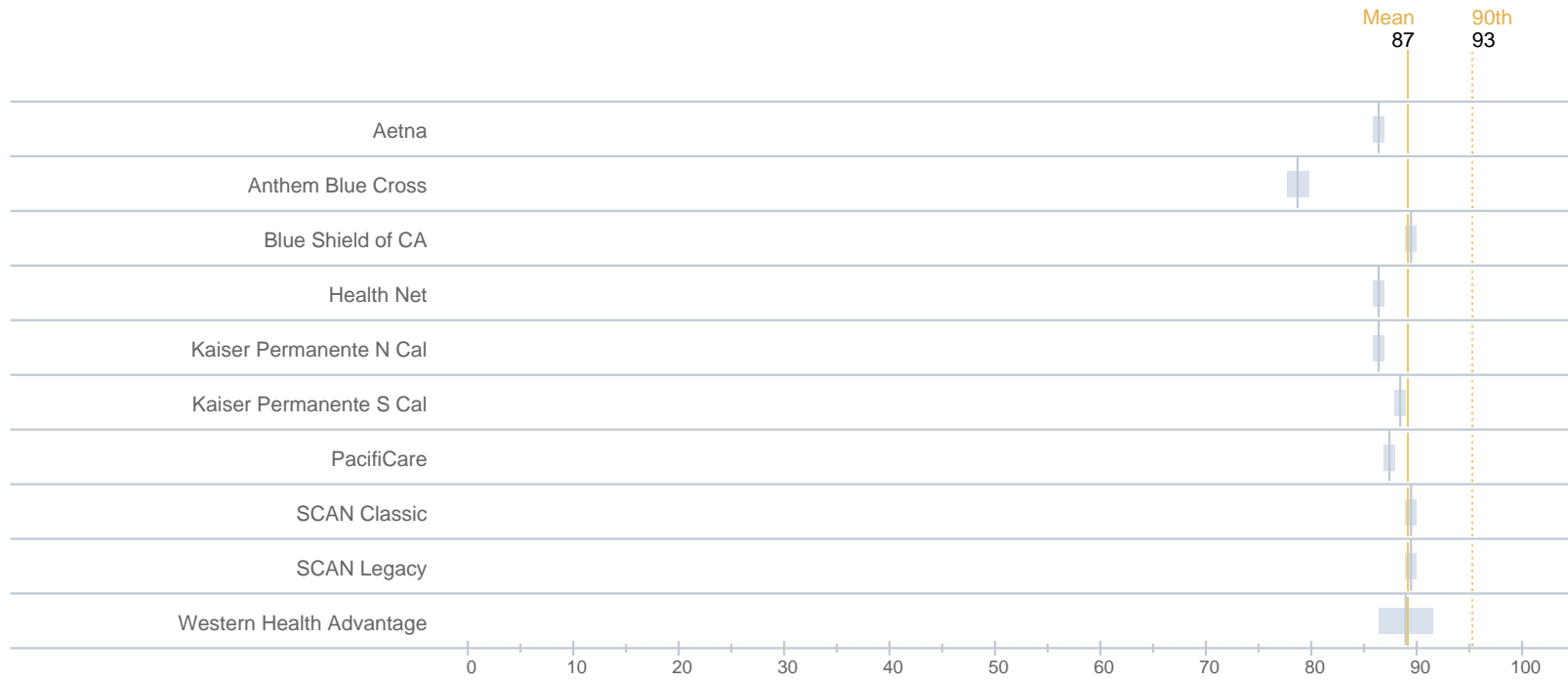

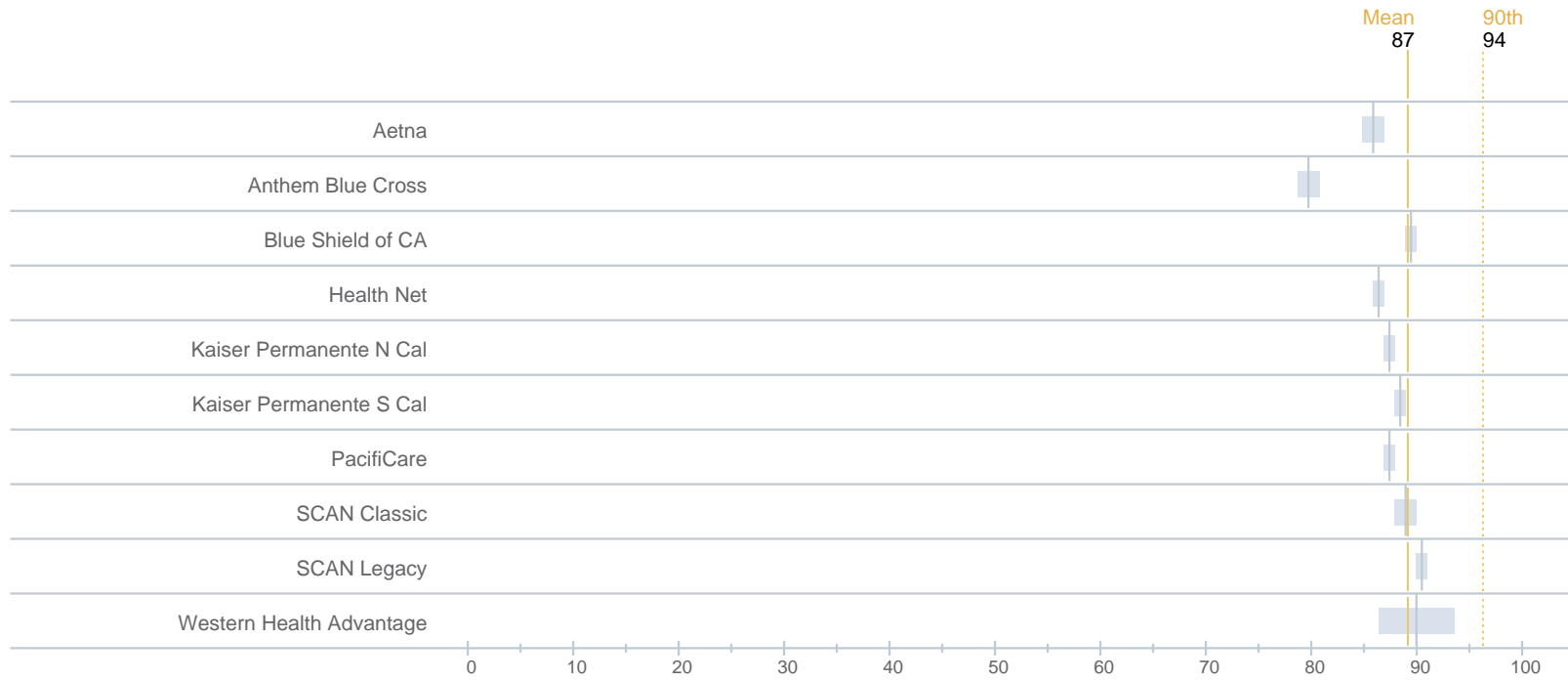
Annual Monitoring Persistent Medications: Total

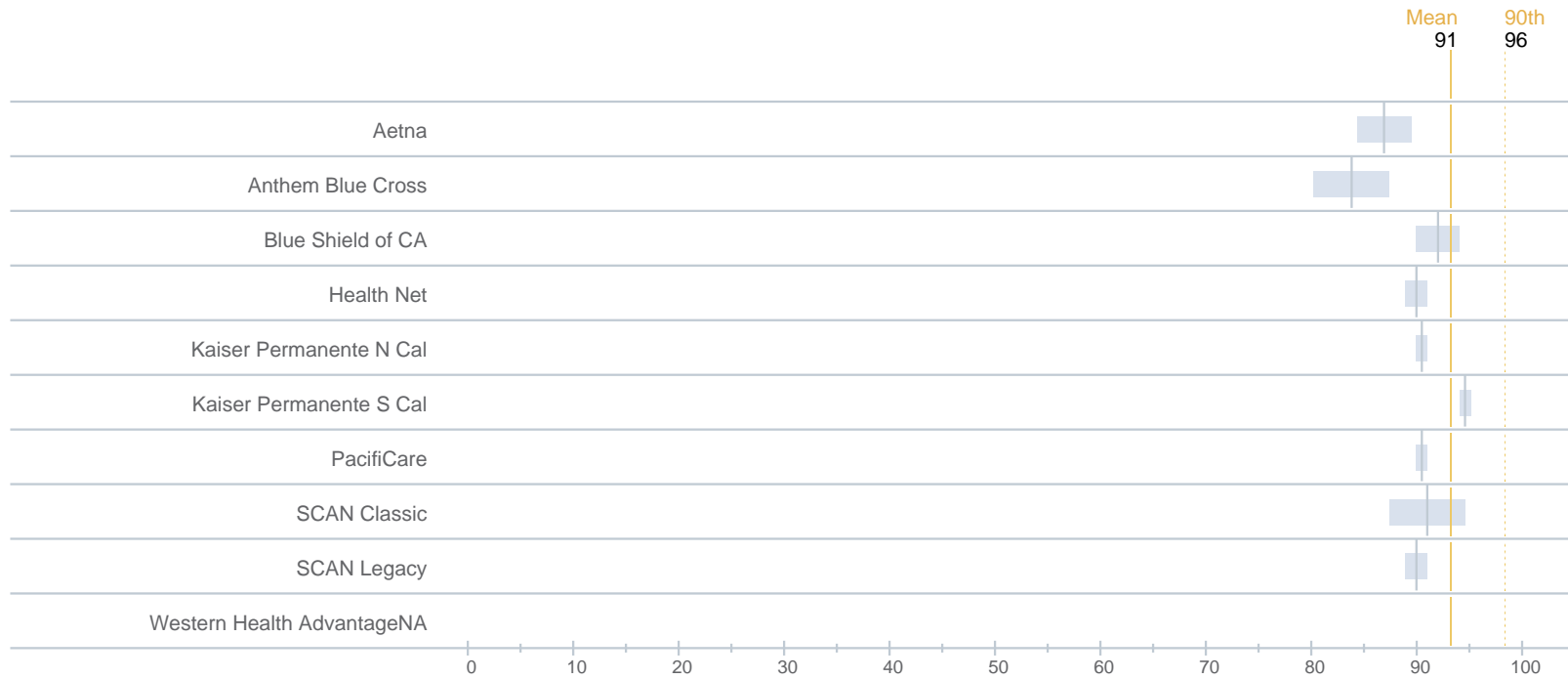
Annual Monitoring Persistent Medications: ACE or ARBs

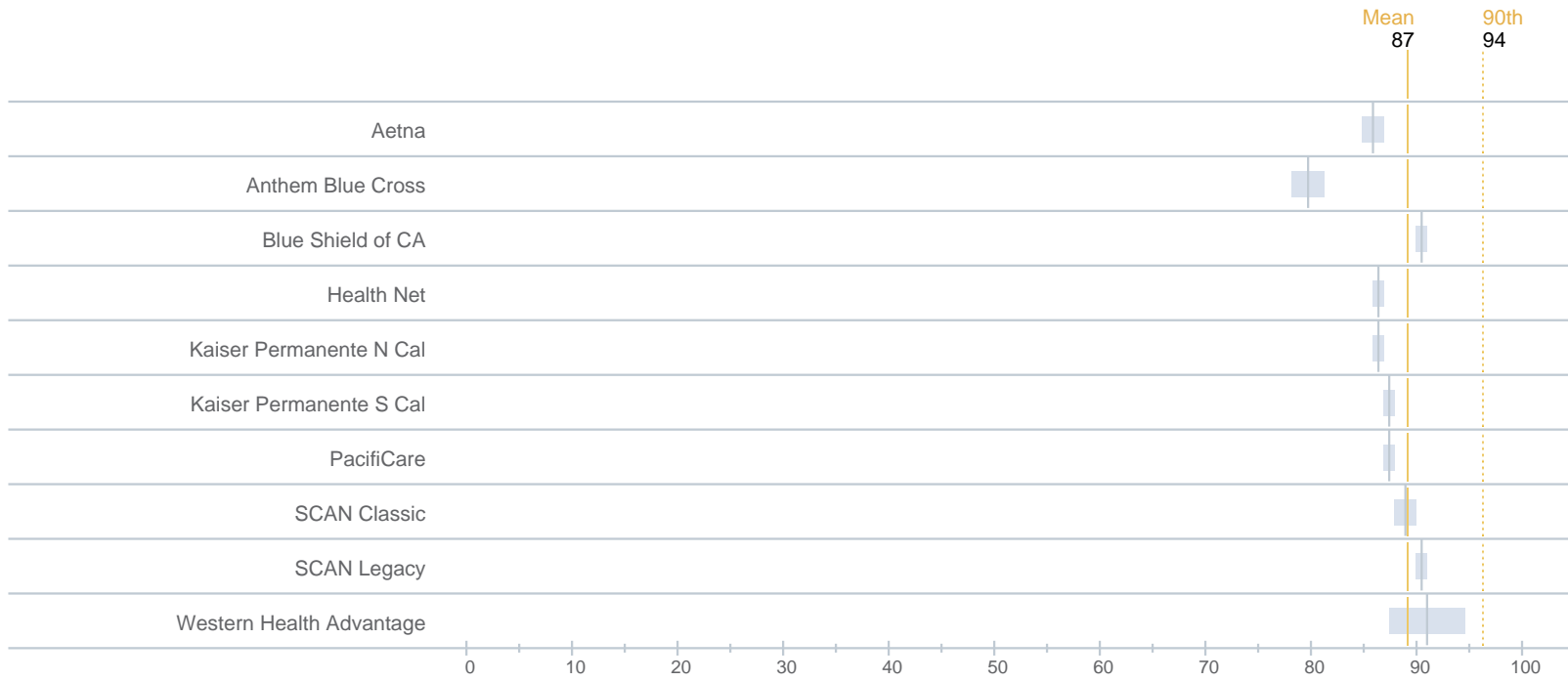

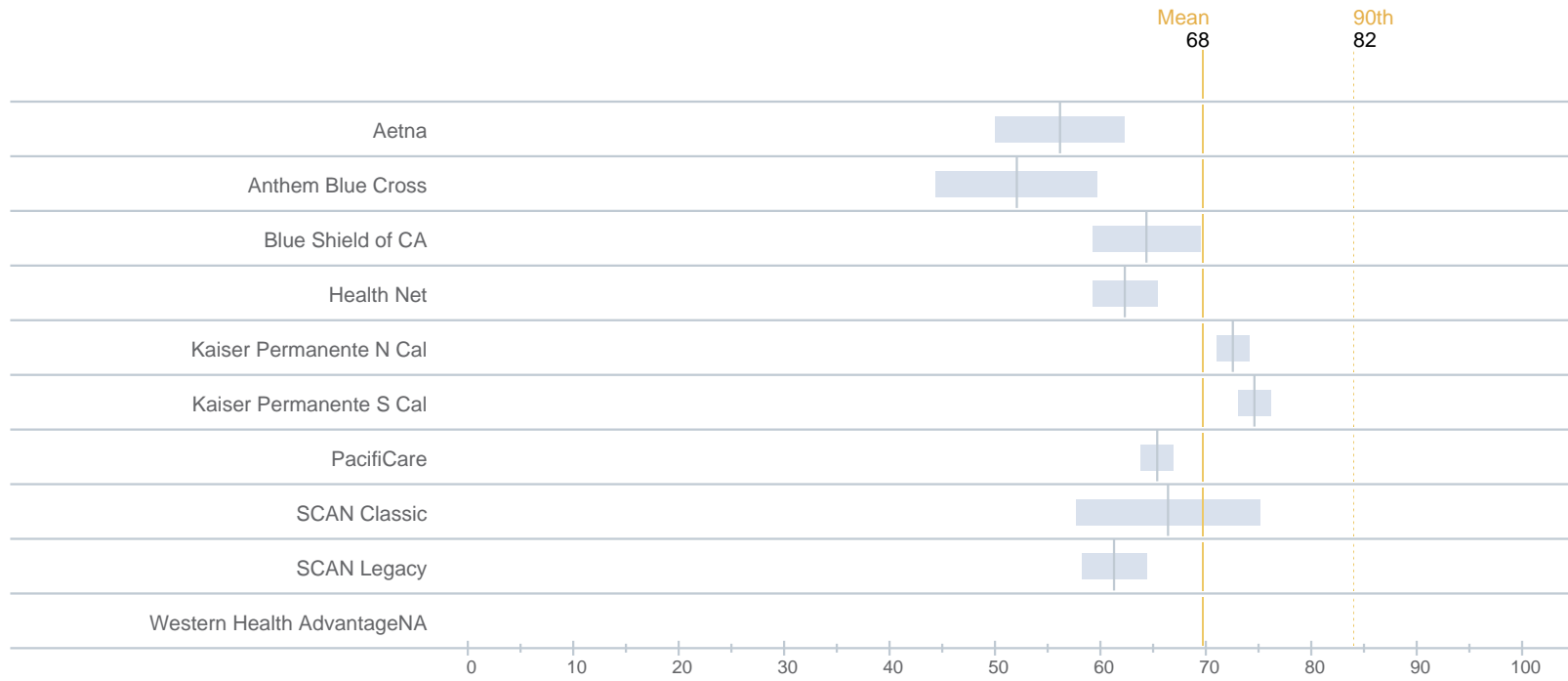

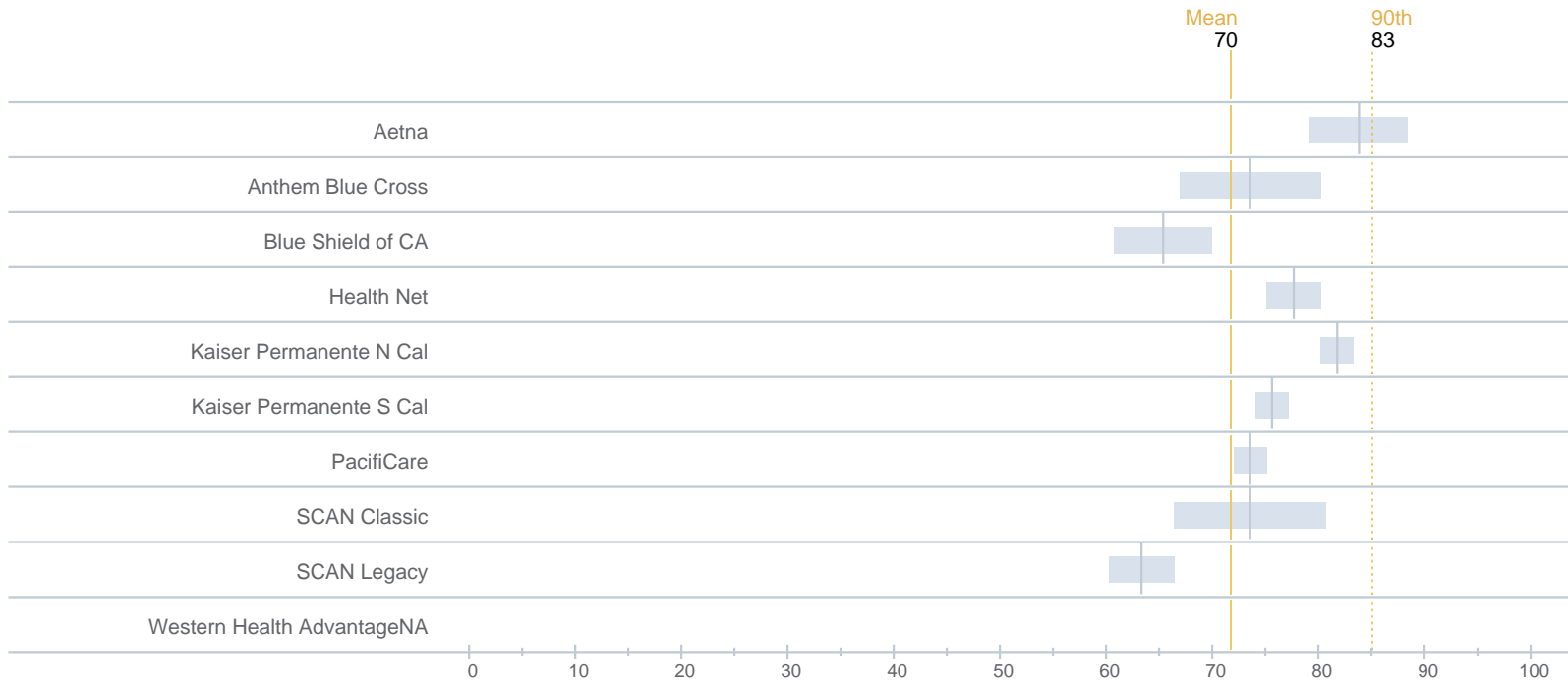

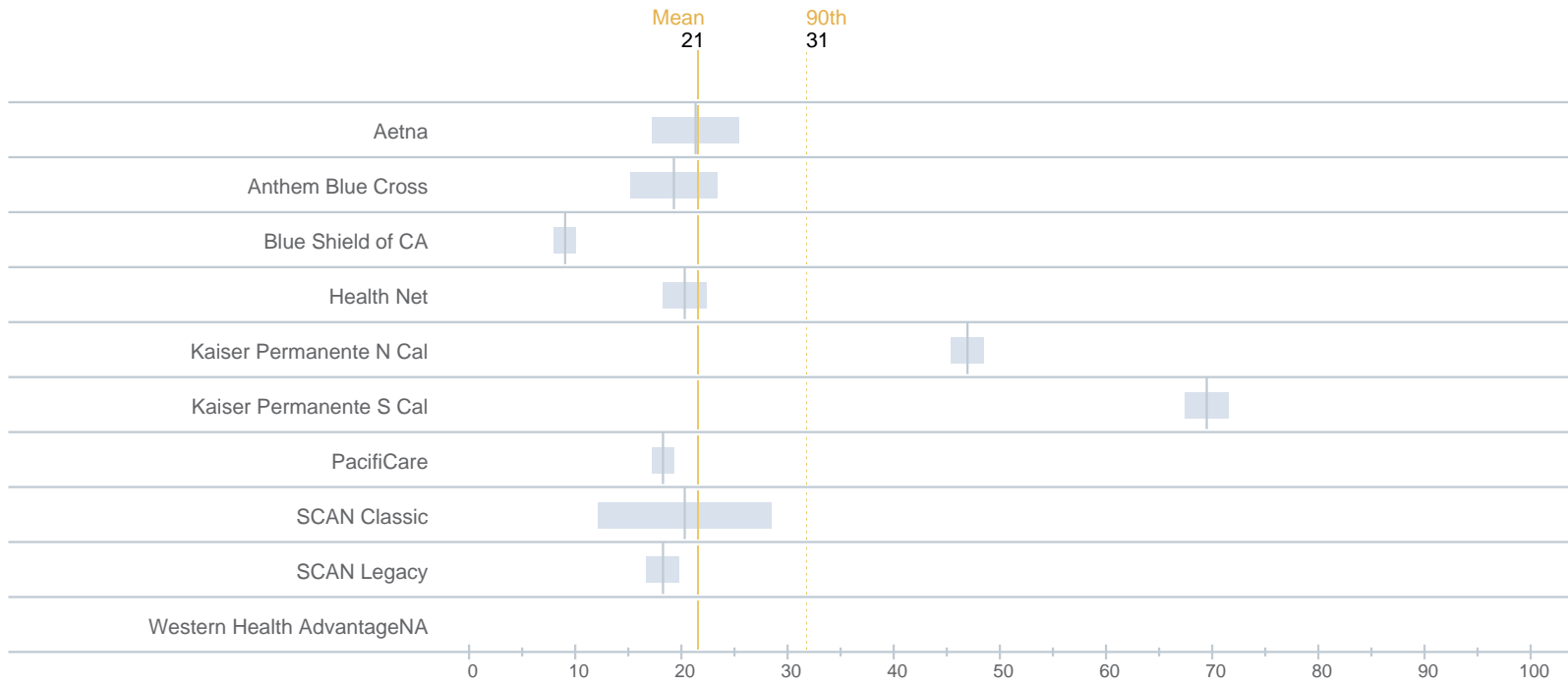

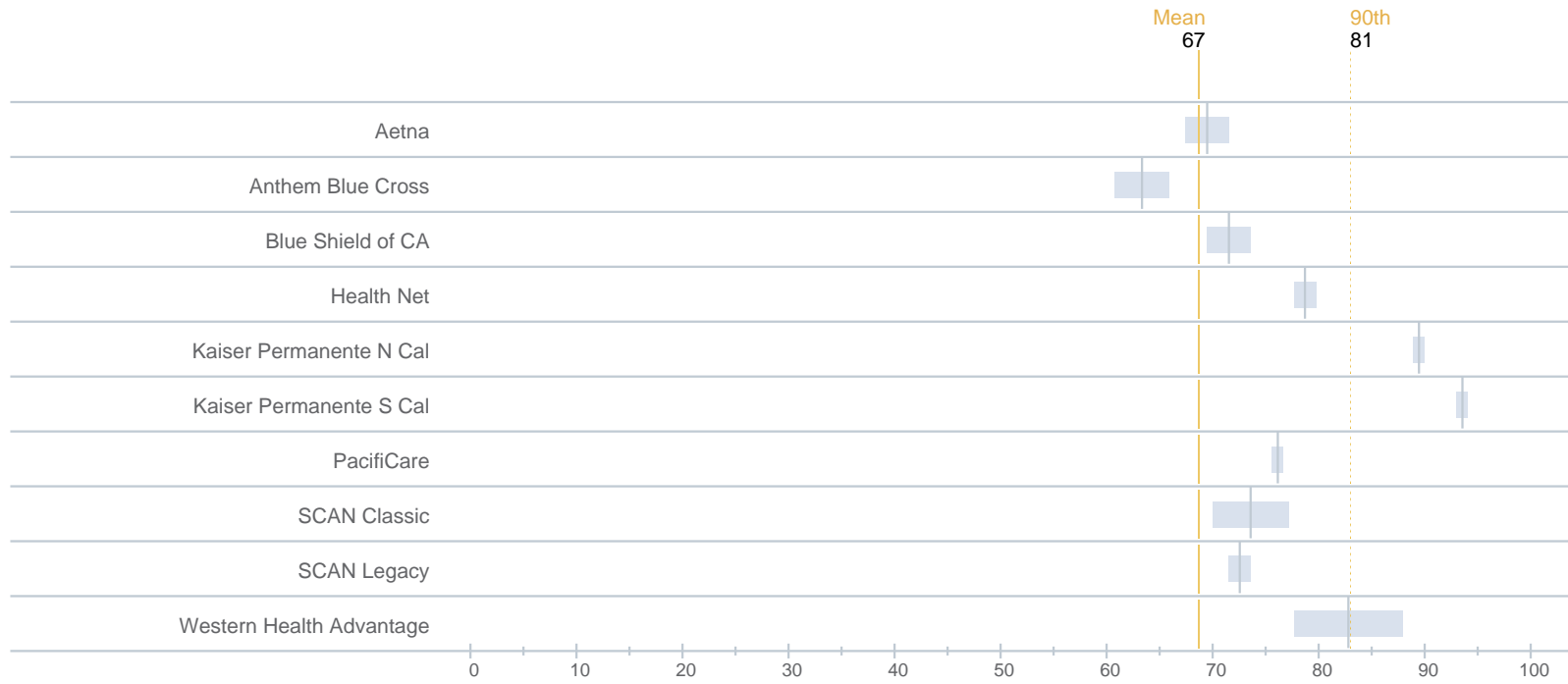

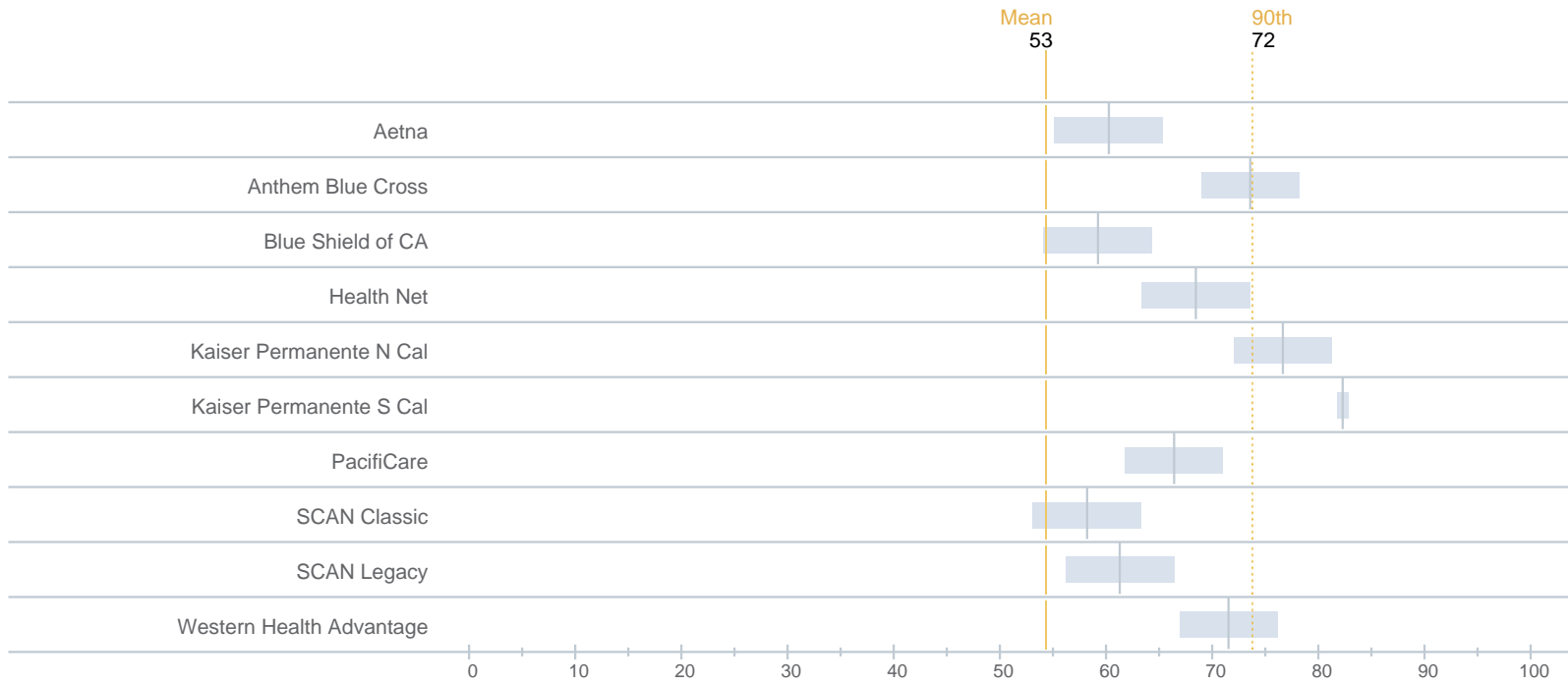
Breast Cancer Screening: Total

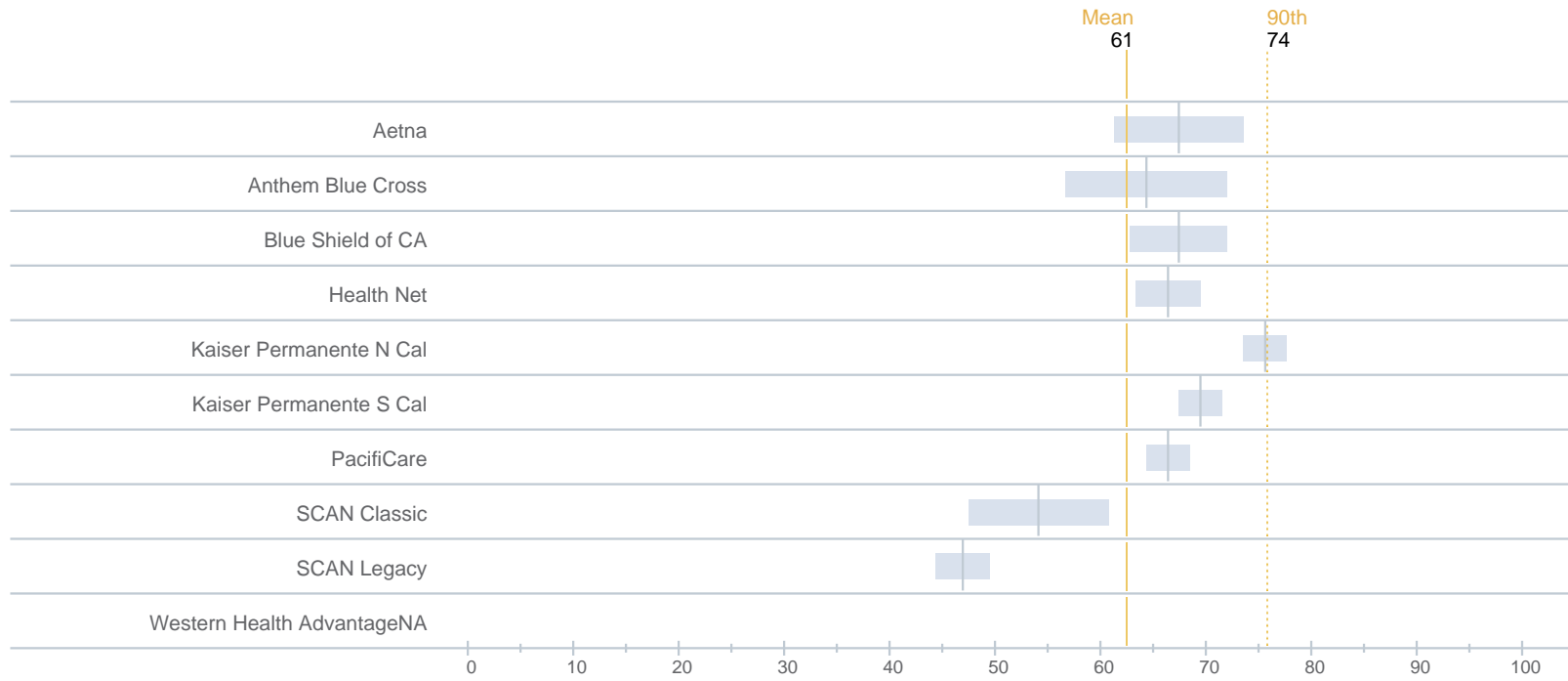
Colorectal Cancer Screening

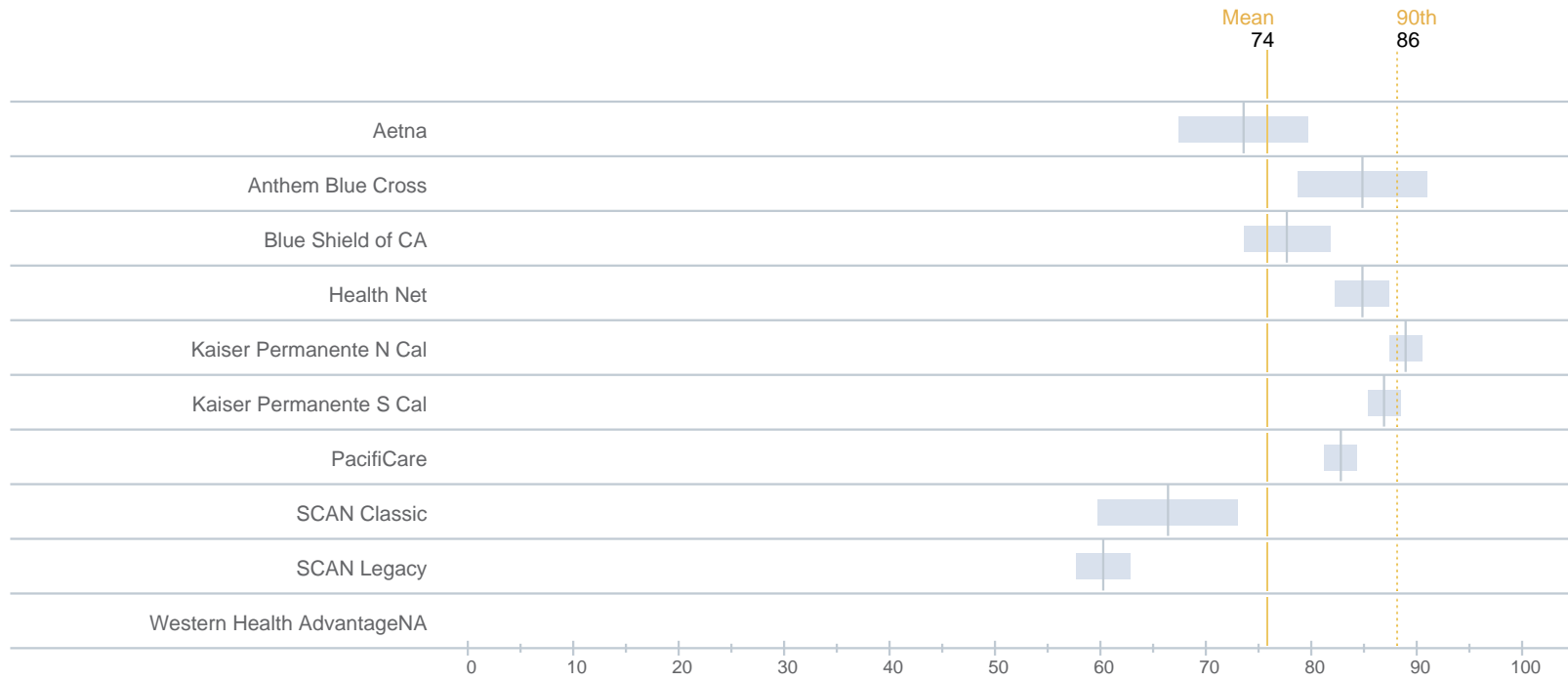
Pharmacotherapy Management of COPD Exacerbation: Systemic corticosteroid within 14 days

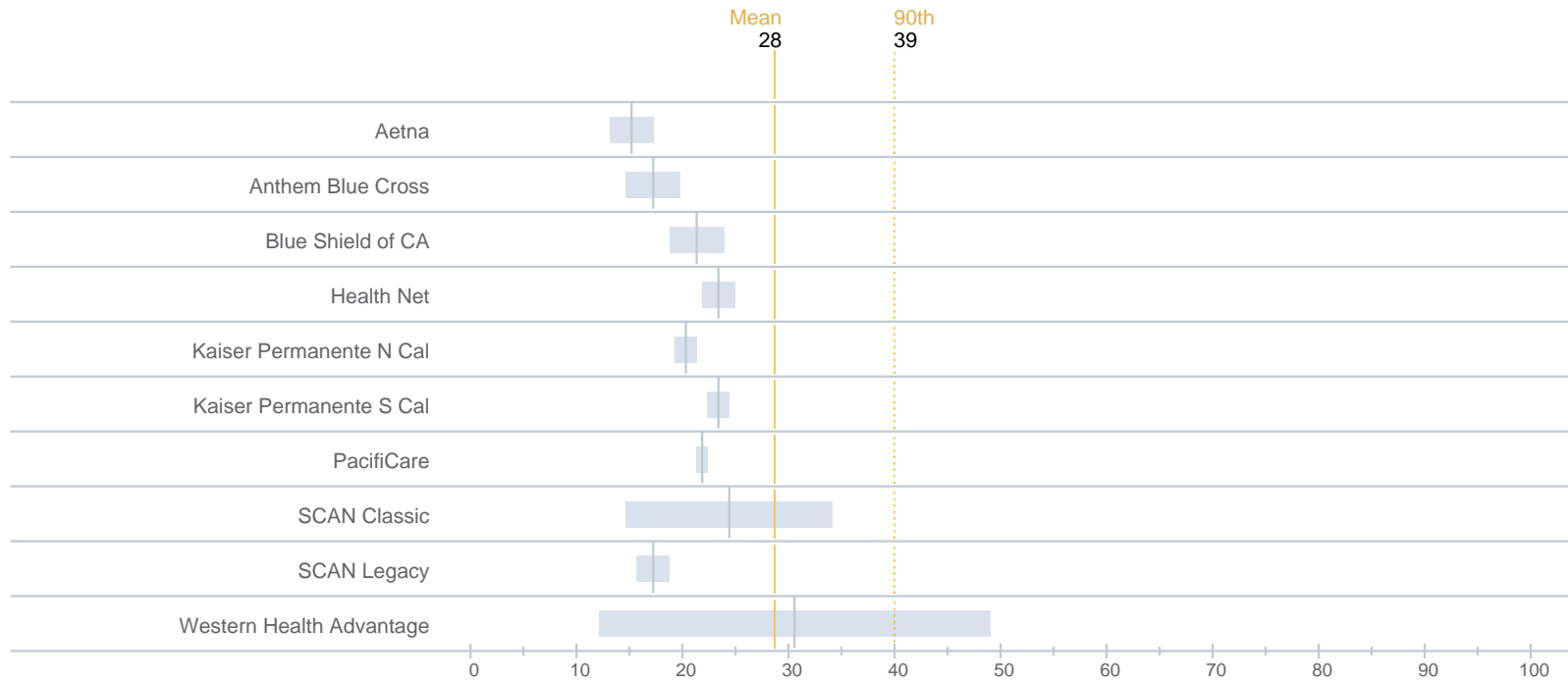
Pharmacotherapy Management of COPD Exacerbation: Bronchodilator with 30 days
